**MOTION TO COMPEL DISCLOSURE OF PUBLIC DEPOSIT, SBLC, PERFORMANCE BOND,
AND ASSOCIATED LEDGER VALUE**

Comes now Shasta Patrice Brown, the living woman and Principal Creditor, in her private capacity as Executor for the Ren-Ira Michal Zuri-El Private Estate, not appearing generally but in special restricted appearance, without submitting to the jurisdiction of the statutory forum, hereby moving this honorable Commission to disclose all public, commercial, and financial instruments generated, held, or monetized in relation to the above-referenced dockets, including but not limited to:

I. GROUNDS FOR RELIEF

1. The filing of a complaint with this Commission may result in the creation of instruments or ledgers posted as liabilities, receivables, or surety positions, with commercial value assigned and entered into public or private financial systems without full disclosure to the living woman named herein.

2. The Commission's own use of the word "deposit" in official filings suggests the possible existence of:

- Escrow accounts**
- Trust accounts**
- Securities posted through bond underwriting or letter of credit**

3. The living woman has reason to believe that the following commercial instruments may have been created, assigned, or monetized in connection with the complaints:

- Standby Letters of Credit (SBLC)**
- Performance Bonds**
- Bid Bonds**
- Municipal or private receivables**
- GSA-registered obligations**
- Instruments assigned a CUSIP number and traded or hedged without full transparency**

4. The Pennsylvania Public Utility Commission, as a public body and administrative agency, is bound by fiduciary duty and full disclosure obligations to those whose filings may be used to generate value in commerce.

5. As the living woman and Executor of the estate named in the dockets above, I hereby demand full accounting and production of any and all:

- Securities, bonds, or trust instruments linked to the docket numbers
- CUSIP registrations or DTCC-held accounts
- Fiduciary assignments or monetized claims under color of authority
- Escrow accounts or deposits entered without notice or consent

II. LEGAL BASIS FOR RELIEF

This demand is made pursuant to lawful standing under the following authorities:

- 15 U.S. Code § 77q and § 78j – Prohibiting concealment or misuse of securities
- 18 U.S. Code § 1341 and § 1342 – Mail and wire fraud, fictitious entities in commerce
- 26 U.S. Code § 643 and § 1231 – Trust accounting and distribution of estate interests
- 42 Pa.C.S. § 2503 – Compensation for abuse of process and concealment
- UCC 3-305 and 3-306 – Claims of holder in due course and notice of dishonor
- 39 U.S.C. §§ 101–403 – Private equity mail protections under federal law
- DMM 608.2.3(e) – Exemption of private mail from USPS rates, acknowledgment of private trust conveyance
- International treaty protections under the UNIDROIT Principles and Lex Mercatoria

III. PRAYER FOR RELIEF

The living woman respectfully demands:


1. Full disclosure of any and all bonds, securities, SBLCs, or deposits created in relation to:
 - Docket No. C-2024-3050759 (PECO Energy Company)
 - Docket No. C-2024-3050761 (Philadelphia Gas Works)

2. A complete audit trail, ledger, or accounting showing how any public or private instrument was monetized, securitized, registered, or assigned.
3. Identification of any account, escrow, or treasury account where proceeds are held, including the identity of the custodian, registrar, or escrow agent.
4. Entry of this motion into the formal record of both dockets, with immediate response compelled within ten (10) calendar days to avoid further dishonor, concealment, or breach of fiduciary duty.
5. That no silence, dismissal, or delay be construed as waiver of rights by the living woman, who does not consent to any commercial use of her filings without full disclosure and remedy.

IV. VERIFICATION

I, Shasta Patrice Brown, the living woman and Executor for the Ren-Ira Michal Zuri-El Private Estate, hereby verify under penalty of perjury that the statements made in the foregoing Motion are true and correct to the best of my private knowledge, information, and belief. This verification is made in good faith, without intent to mislead, and without submission to the jurisdiction of the United States or its political subdivisions.


