Dear Ms. Mann:

On June 18, 2025, Electricity Ratings, LLC (Electricity Ratings) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide natural gas services, as a broker/marketer, to Electricity Ratings, LLC d/b/a 1776 Energy d/b/a PA Energy Ratings d/b/a Ability Energy d/b/a Utility Rates.

Currently, Electricity Ratings is licensed as Electricity Ratings, LLC as a broker/marketer to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division<sup>1</sup>, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc.<sup>2</sup>, and Valley Energy, within the Commonwealth of Pennsylvania.

Electricity Ratings has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of Electricity Ratings, LLC's name on its license for the provision of natural gas services as a broker/marketer.

**The Secretary's Bureau will issue a new license to Electricity Ratings, LLC d/b/a 1776 Energy d/b/a PA Energy Ratings d/b/a Ability Energy d/b/a Utility Rates the right to begin to offer, render, furnish, or supply natural gas services as a broker/marketer to residential, small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas**
