I am writing to formally reaffirm my position regarding the proposed telephone hearing in the above-referenced matter. As stated in prior correspondence and confirmed with Ms. Morris on July 31, 2025, I do not Consent to a telephone hearing. This refusal is grounded in procedural integrity and sovereign right to due process.

Despite my clear position, opposing Counsel has ignored all Verbal and Written Correspondence, continued to contact me repeatedly – at least 7 times in the past week alone – and has indicated intent to file a Motion suggesting I do not wish to continue with proceedings. This is Inaccurate and Misleading. I remain fully engaged and have submitted all required filings, including testimony and procedural documentation. ** **Embedded International Filings and Notice of escalation to the International Peace Tribunal if remedy is either denied, or ignored.***

Important Note:** Prior **Registered & Restricted** mailings to Harrisburg have experienced **delays of up to three weeks;** the **OIG for the USPS** was contacted by both me, and the **Harrisburg Postmaster**, concerning this delay; **reason provided: Use of Automation.

Failure to Honor and Recognize the pending Quiet Title Action and Invocation constitutes: Breach of Covenant & Trust, Fiduciary Failure, Moral Turpitude, Procedural Sabotage, and Willful Denial of Remedy.

*Given both **Aqua Pennsylvania's** and **PPL Electric's** documented history of **surprise terminations, refusal to engage in lawful process, the massive breach of trust, amount of harm inflicted, and property damage incurred, Injunctive Relief pending further Order of Court, is requested. The Motion and Order were accidentally omitted from original Service packet, and an Amended POS was necessary, therefore, they are all included herein.***

Amended Proof of Service

I, Bishop Roxane-Corpus-Christi, FKA. “Roxane-(C.C.): Leaveck-Koshinskie, and “ROXANE/ROXANNE (C.C.) LEAVECK”, do hereby affirm the following:

1. On August 7, 2025, I entered the Northumberland County Recorder of Deeds Office to file a **Quiet Title Action**. “**Ms. Mertz**” appeared visibly flustered and agitated. She first refused to accept the filing stating she needed to speak with her Solicitor, who was “away on vacation for a few weeks”. I explained to her that this action must be filed due to the **adverse action**, filed by **EQUITY TRUST CO. – CV-25-937**, which is currently pending before the Court. She demanded a fee, and was informed it was being filed “*In Forma Pauperis*”. She continued to refuse to file, and disclose the exact amount of her fee, and started yelling, “Did you write an Order?”. Upon asking for clarification, she screamed for the other clerks to press “**the Panic Button**”, thereby activating approximately **seven armed deputies** to facilitate my removal from the Courthouse.

Service & Filing: Refused.

2. **Sheriff Wolfe** intervened at my request and provided an escort to Civil Division to file it with the Prothonotary in Response to **CV-25-937**. The Sheriff and Counsel **Refused Service** despite being notified of Equity Trust Company’s false affidavit.

3. Due to the unanticipated hostility, chaos, and confusion, the filing took longer than expected.

4. The Post Office in Sunbury was closed upon arrival, so the parties to the PUC Dockets could not be served until August 8th.

5. Due to expected mail delivery dates, scheduled Court events, erroneously omitted pages, and missing Motions for Injunction and Orders, these parties were also notified and served via fax, on August 11th.

6. **This filing constitutes Constructive Notice. Refusal does not Negate Service. Jurisdiction is now Affirmed.**

Memorandum of Law in Support of Petition to Proceed

In Forma Pauperis

Filed by: Bishop Roxane- Corpus- Christi

I. Statement of Purpose

This memorandum supports Petitioner's motion to proceed in forma pauperis, asserting lawful exemption from Court fees based on trust-held assets, non-commercial standing, and duties as Cestui Que Vie and Lawful Heir. This request reflects not only financial hardship but also structural exemption arising from sacred holdings and sovereign alignment.

II. Governing Law & Authority

*** Pennsylvania Rule of Civil Procedure 240 (Pa. R.C.P. 240)**

Grants relief from filing fees to individuals unable to pay without undue hardship. No income threshold nor formal financial disclosure is mandated if alternative evidence of hardship is presented.

*** Mortmain Doctrine & Sacred Trusts**

Assets held in Mortmain and/or Ecclesiastical Trust are shielded from secular valuation. They shall not be construed as liquid or taxable property and are expressly removed from consideration under Pa. R.C.P. 240, consistent with both historic and contemporary equity.

*** Sovereign Filings & Good Faith Clause**

All filings made by Petitioner are non-frivolous, required of her by Divine Mandate, and are in pursuit of Title and Estate Restoration, and Reparative Justice. The Pennsylvania Supreme

Court has emphasized that fee waivers apply where filings are sincere and substantively grounded.

III. Factual Basis

Petitioner maintains no participation in Commercial Markets nor financial systems subject to Civil Jurisdiction. All Sacred holdings remain under Divine and ancestral authority, and are Exempt from Lien, Levy, or Administrative Encumbrance. No Known Debt Obligations Exist that can be satisfied through these holdings.

IV. Conclusion and Relief Requested

Petitioner respectfully asserts lawful Exemption from filing fees based on her status, holdings, and the nature of this action. Relief is sought pursuant to Pa. R.C.P. 240 and supporting Jurisprudence, with Affirmation of Good Faith and Substantive Merit. 1. Petitioner Identity

*Roxane-Corpus-Christi, Bishop for The Æthereal House of the Dawn, FKA "Roxane (C.C.)
Leaveck-Koshinskie" daughter and widow of the above named decedents, was issued Short
Certificates as Administrator of their Estates and Trusts, on February 6, 2013 (Gloria P.
Leaveck); December 17, 2014, (Thomas I. Leaveck); and November 27, 2023, (David J.
Koshinskie).*

2. Appointment & Circumstances

*Said "appointments" were made **without fully informed consent**, while under severe duress,
with undue influence, and in circumstances lacking full disclosure regarding legal and fiduciary
capacity and obligations, therefore, **assumed no Estate or Trust liabilities nor obligations.***

3. Basis for Revocation

*I seek **Revocation of Letters of Administration** under 20 Pa. C.S. 3182 & 3184 of the Probate,
Estates & Fiduciaries Code, asserting:*

** I discovered via investigation under the Qui Tam provisions of the USC, performed between
2020 & 2025, that **all parties** involved in "closing" Estates were and are, working-in-tandem,
either intentionally, or via ignorance combined with conflicting bureaucratic processes and*

*legalese practices. The net effect has been to **deprive** benefices and heirs of both trust access, and inheritance, for an undetermined length of time.*

** Between 2012 and 2015, my mother, father and husband were diagnosed with terminal cancer. The loss of my mother and father in rapid succession, followed by the diagnosis of my husband, left me in a state of **profound post traumatic distress** coupled with personal loss. The state my husband was in, in 2023, due to profound Fiduciary neglect – like that of an Auschwitz victim - destroyed any remnant that was left. **No One deserves to suffer that way – Absolutely No One.***

** Short Certificates as Administratrix were issued to me between 2013 and 2023, while I was emotionally and mentally compromised, and **under severe duress**, by **trusted Attorneys** – one of whom is known to me personally for over 3 decades – the other, for over a decade.*

** **Lifetime savings, including 401 K funds**, were used as **leverage** by Fiduciaries to coerce the appointment in 2023. **Counsel for the Estate abandoned his duties in January 2024.***

** Multiple Incidents of Fiduciary Failure **Compounding Misrepresentation and Fiduciary Breach.***

** Innumerable intentional acts of **Moral Turpitude** by hired Counsel to Misidentify Benefices and rightful heirs as **Indentured Fiduciaries** under false pretenses, for **personal and/or financial gain.***

** Inability to continue Representation due to **Lack of Original Informed Consent**, multiple **Conflicts of Interest**, and complete and total **Lack of Cooperation** on the part of other **Fiduciaries** in properly settling the Estate and distributing inheritance to benefices.*

** **No Estate Administration actions have been taken that legally bind nor obligate either Petitioner or other Benefices and heirs.***

** **Revocation will Not Prejudice Creditors nor affect Distribution Rights of other Heirs.***

MOTION FOR PRELIMINARY INJUNCTION

Petitioner respectfully moves this Honorable Court for a Preliminary Injunction pursuant to Pa. R.C.P. 1531, and in support thereof, avers as follows:

*1. Petitioner has filed a **Quiet Title Action and Notice to Defend**, asserting lawful claim and sovereign standing over ancestral Estate, Cestui Que Trust and utility jurisdiction. This filing is tied to an **Irreparable Harm** claim established in **PASC 132 MM 2024**, for which **Respondents are in constructive default for Failure to Respond**.*

*2. Petitioner proceeds **in Forma Pauperis** under sovereign invocation, **no bond** shall be imposed, as such demand is **void** under both procedural law and ancestral jurisdiction.*

*3. Petitioner is engaged in an **active proceeding** before the Pennsylvania Public Utility Commission, (PUC), docketed and served, **with receipts**.*

*4. Respondents are currently in **Default for Failure to Respond** to all **Objections, Rebuttals and Responses**.*

*5. Despite pending Formal Case, history of disputed debt obligation claims, and **verified receipt of service**, Respondent, PPL Elec. Utilities, **unlawfully terminated** essential electric service in July, 2025, in violation of **State and Federal Debt Collection Laws, and 52 Pa. Code 56.100 et. seq.***

*6. The presiding PUC Judge **refused to enforce regulatory protections** to have service immediately restored, resulting in **retaliatory harm and procedural sabotage**.*

7. Petitioner's sister was forced to pay the disputed amount under duress, via credit card, to restore service, constituting **coercion and breach of due process**.

8. Petitioner and children face **immediate and irreparable harm**, including disruption of Court filings, record integrity and sovereign motion. Petitioner has suffered **unreimbursed** property damage from surprise terminations.

9. **By Respondents own previous admission Petitioner somehow has Seven (7) accounts.**

10. Petitioner has requested **Level 3 forensic audit** of trust/s in **ALL** Court filings.

11. **No adequate remedy exists at law**, as administrative channels have failed to protect Petitioner's rights.

12. **Petitioner is likely to succeed on the merits**, having documented violations, served lawful filings, maintained meticulous records and procedural integrity, to the best of her ability.

13. **The balance of harms favors Petitioner**, whose life and children's lives, trust and estate, are endangered by continued forcible theft, retaliation, and sabotage.

14. **The public interest supports relief**, as utility abuse and administrative failure affect all peoples.

WHEREFORE, Petitioner respectfully requests this Court to:

* **Issue a Preliminary Injunction** prohibiting further harassment, retaliation, or termination, pending further **Order of Court**.

* **Enjoin Respondent** from interfering with, or trespassing upon, Petitioner's Estate, Trust/s, filings, or transmissions.

* **Grant such other relief as this Court deems just and proper.**

MOTION FOR PRELIMINARY INJUNCTION

*Petitioner respectfully moves this Honorable Court for a Preliminary Injunction pursuant to
Pa. R.C.P. 1531, and in support thereof, avers as follows:*

- 1. Petitioner has filed a **Quiet Title Action and Notice to Defend**, asserting lawful claim and sovereign standing over ancestral Estate, Cestui Que Trust and utility jurisdiction. This filing is tied to an **Irreparable Harm** claim established in **PASC 132 MM 2024**, for which **Respondents are in constructive default for Failure to Respond**.*
- 2. Petitioner proceeds **in Forma Pauperis** under sovereign invocation, **no bond** shall be imposed, as such demand is **void** under both procedural law and ancestral jurisdiction.*
- 3. Petitioner is engaged in an **active proceeding** before the Pennsylvania Public Utility Commission, (PUC), docketed and served, **with receipts**.*
- 4. Respondents are currently in **Default for Failure to Respond** to all Objections, Rebuttals and Responses.*
- 5. Respondents work in tandem with **KMJSA Inc.**, to terminate services. KMJSA, CEO, and Solicitor are in Constructive **Default for Failure to Respond** in **PASC 132 MM 2024**, and the **Verified Counterclaim to CV-25-93**. (They are **known parties to the action** who are **not** properly joined by the initiating adverse party.)*
- 6. Respondents have a history of “**surprise terminations**”, forced collection at gunpoint and under threat of immediate arrest, arranging automatic credit card payments without authorization, and forcible trespass resulting in **extensive in property damage**.*

7. The PUC Secretary's Office apparently **"lost"** Petitioner's **Responses, Rebuttals, and Objections**, in two separate cases, as the presiding PUC Judges claim to have not received them, despite verified receipts.

8. Petitioner and children face **immediate and irreparable harm**, including disruption of life sustaining water resulting in loss of sovereign motion.

9. Petitioner has suffered **Extensive Property Damage** from: surprise terminations, unlawful trespass by Agent, "Larry Rompolo", intentional destruction of property, and forced excavation by multiple Agents, while at gunpoint, and in trespass, resulting in further property damage.

10. Petitioner has requested **Level 3 forensic audit** of her trust/s in **ALL** connected Court filings including: PUC Docket: 3054597; CV-25-937; and PASC 132 MM 2024.

11. **No adequate remedy exists at law**, as administrative channels have failed to protect Petitioner's rights.

12. **Petitioner is likely to succeed on the merits**, having documented violations, served lawful filings, maintained meticulous records and procedural integrity, to the best of her ability.

13. **The balance of harms favors Petitioner**, whose life and children's lives, trust and estate, are endangered by continued theft, retaliation, and sabotage.

14. **The public interest supports relief**, as utility abuse and administrative failure affect all peoples.

WHEREFORE, Petitioner respectfully requests this Court to:

* **Issue a Preliminary Injunction** to Respondent and KMJSA Inc., prohibiting further harassment, retaliation, or termination, pending further Order of Court..

* **Enjoin Respondent and KMJSA Inc.** from interfering with, or trespassing upon, Petitioner's Estate, Trust/s, filings, or transmissions.

* **Grant such other relief as this Court deems just and proper.**
