4. The Commission’s [Order of October 27, 2022](#) stated that: “The substance of the NWMA petitions **shall be addressed by separate Opinion and Order.**” [October 2022 Order](#) at 8, footnote 3 (emphasis added).

5. In 2024, Aqua and NWMA entered into a contract regarding the provision of water service pursuant to the Rider DRS provisions of Aqua’s tariff. That now-existing contract was registered with the Commission. See [Secretarial Letter](#) and [Certificate](#) at PUC Docket No. [U-2024-3046423](#).

6. To date, the Commission has not addressed the substance of NWMA’s 2022 Petitions in a separate Opinion and Order.³ Rather than require the Commission to expend time and effort on the substance of NWMA’s 2022 Petitions, NWMA believes it would be best to withdraw the 2022 Petitions and is notifying Aqua, the statutory advocates and the other persons listed on the attached Certificate of Service of the requested withdrawal.

WHEREFORE, NWMA respectfully requests the Commission issue an Order (a) granting leave to withdraw both of NWMA’s 2022 Petitions; and (b) marking both of NWMA’s 2022 Petitions as withdrawn.
