Application of Verizon Pennsylvania, LLC for approval to alter the public crossing (DOT 266 115 F) by lowering an existing aerial communication cable facility where State Route 3015 (Moosic Road) crosses, at grade, the track of Reading Blue Mountain & Northern Railroad Company located in Old Forge Borough, Lackawanna County.

To Whom It May Concern:

By Secretarial Letter dated June 2, 2023, and modified on July 11, 2024, Verizon Pennsylvania LLC (Verizon) was directed to complete the crossing alteration on or before May 31, 2025.

By letter-petition received by the Commission on August 20, 2025, Verizon requests an additional extension of time to complete the alteration of the crossing involved in the above captioned proceeding.

In its letter-petition Verizon stated that the project was delayed due to a backlog in construction. Verizon is therefore requesting an additional extension of time that establishes a completion date of May 31, 2026.

We have carefully reviewed the record in this proceeding and will grant Verizon Pennsylvania LLC an additional extension of time to May 31, 2026, to complete the alteration of the above captioned crossing.

This Commission issues this Secretarial Letter in accordance with Section 2702 of the Public Utility Code.

THEREFORE:

The letter-petition of Verizon Pennsylvania LLC received by the Commission on August 20, 2025, requesting an additional extension of time, be and is hereby granted to the extent herein directed:

1. Paragraph 9 of our Secretarial Letter dated June 2, 2023, and modified on July 11, 2024, which reads as follows, to wit:

“9. The alteration of the crossing be completed on or before May 31, 2025, and that on or before said date Verizon Pennsylvania, LLC report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plans and this Secretarial Letter.”

be and is hereby modified to read:

9. The alteration of the crossing be completed on or before May 31, 2026, and that on or before said date Verizon Pennsylvania LLC report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plans and this Secretarial Letter.

2. In all respects not inconsistent herewith, our Secretarial Letter dated June 2, 2023, remains in full force and effect.

The Parties are reminded that failure to comply with this or any Order or Secretarial Letter in this proceeding may result in an enforcement action seeking civil penalties and/or other sanctions pursuant to 66 Pa. C.S. § 3301.



If you are dissatisfied with the resolution of this matter, you may, as set forth in 52 Pa. Code §§ 1.31 and 5.44, file a Petition for Reconsideration from Staff Action (Petition) with the Commission within twenty (20) days of the date of this letter. The Petition shall be eFiled with the Secretary of the Commission or sent to: Secretary, PA Public Utility Commission, 400 North Street, Harrisburg, PA 17120, and must be filed within twenty (20) days, or if no timely request is made, the action will be deemed to be a final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request; (2) the case docket number (it is provided for you at the top right-hand corner of this letter); (3) the party on whose behalf the petition is made; (4) a Certificate of Service on the other parties of record; and (5) a Verification with original signature in accordance with 52 Pa. Code § 1.36.
