Litigation Schedule of Dorene Dougherty

Pursuant to Section 333 of the Public Utility Code, 66 PA Section 333 and in response to the Prehearing Conference Order in the above Captioned Matter, Complainant, Dorene Dougherty Provides the following information:

On March 5, 2025 Administrative Law Judge, Chad Allensworth issued a prehearing Conference Order which states in part:

That parties shall review the regulations pertaining to Prehearing Conferences, in particular 52 PA Code 5.222(d) which provides that parties and Counsel will be expected to attend the Conference prepared for useful discussion of all problems involved in the

Proceeding, both procedural and Substantive, and fully authorized to make commitments with respect thereto. The preparation should include, among other things, gathering and advance study of all relevant materials and advance informal communication between the Participants, including requests for additional data and information, to the extent it appears feasible and desirable. Specifically, the Parties shall be prepared to discuss, (a) hearing dates (b) updates on any proposed witnesses (c) whether the Parties still wish to proceed with live direct testimony and (d) any other case management concerns.

Dorene Dougherty intends to present and discuss the following:

1. Separate Interrogatories were previously mailed to Pennsylvania Electric Company requiring answer.
2. THE AFFIDAVIT OF DR. GUNNAR HEUSER
3. Dr. Gunnar Heuser as witness and Personal Physician.
4. Dr. Gunnar Heuser's published Brain Scan studies
5. Several papers by Haxas, M; Milham S on dirty electricity

b. 66 PA. C.S. 1501. Section 1501 of the Public Utility Code requires every public utility in Pennsylvania to "maintain adequate, efficient, safe and reasonable services and facilities" and to "make all such repairs, changes, alterations, substitutions, extensions and improvements in or to such services and facilities as shall be necessary or proper for the accommodation, convenience, and safety of its patrons, employees, and the public." 66 PA C.S. 1501. Pursuant to that authority and Section 501 of the public utility Code, 66 Pa C.S. 501, the Pennsylvania Public Utility Commission (Commission or PUC) proposes adding safety regulations with respect to the distribution facilities of electric utilities under the Commission's jurisdiction.

7. Article VI, Paragraph 2 of the US Constitution is commonly referred to as the Supremacy Clause. It establishes that the federal Constitution, and federal law generally, take precedence over state laws, and even state constitutions. It prohibits states from interfering with the federal government's exercise of its constitutional powers, and from assuming any functions that are exclusively entrusted to the federal government. The Bill of Rights is inviolable with respect to the states.

8. Reserves the right to call both expert and non-expert witnesses in the future as necessary.

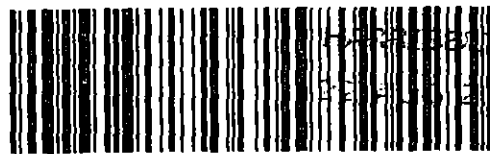

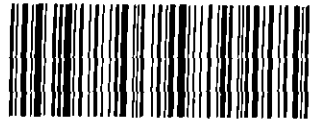
