**INTERIM ORDER
ON MOTION TO STRIKE**

On September 4, 2025, the Evidentiary Hearing in this matter, Citizens Electric Company of Lewisburg, PA (Citizens) made an oral motion to strike page 37, line 6 through page 43, line 20 of Solar Projects Statement 2-SR, Surrebuttal Testimony of Kevin Lucas. Following oral argument from Citizens and Solar Projects, I denied the motion.

However, I granted Citizens leave to respond to the surrebuttal material by offering supplemental rejoinder testimony.

THEREFORE,

IT IS ORDERED:

1. That Citizens may serve Supplemental Rejoinder Testimony of Nathan Johnson **by noon on September 9, 2025.**

2. That Solar Projects must notify the Parties and presiding officer whether Solar Projects wishes to cross-examine Mr. Johnson regarding the Supplemental Rejoinder Testimony or whether it will stipulate to waive cross-examination and agree to the admission of Mr. Johnson's written Supplemental Rejoinder Testimony **no later than 4 p.m. on September 9, 2025.**

3. A further hearing will convene by telephone on **September 10, 2025, at 8:30 a.m.** for the limited purpose of the cross-examination of Mr. Johnson or to entertain the offer of the admission of Supplemental Rejoinder Testimony into the record.
