To Whom It May Concern:

The purpose of this Letter is to advise you that your Application, Docket No. A-2025-3056159, has been **DENIED** by the Pennsylvania Public Utility Commission (Commission). The Commission has determined that a Certificate of Public Convenience **WILL NOT BE GRANTED** for the following reason(s):

- **Lack of financial fitness:**

On July 9, 2025, the applicant submitted an application for call or demand authority. Upon review numerous deficiencies were noted. The applicant was subsequently issued two separate data requests seeking to establish the applicant's fitness to operate and its ability to provide safe, efficient, and reasonable service.

In the course of the applicant's responses, probable issues were observed with the applicant's intended business model and its financial fitness. Review of the applicant's supporting documentation and submitted statements indicated a lack of financial liquidity and a lack of essential vehicular equipment. Despite two attempts by the Commission to elicit evidence of a registered vehicle, the applicant has still failed to establish that it owns a vehicle with which to provide the requested service.

In weighing the applicant's minimal cash reserves against its need to obtain a vehicle which is able to be properly registered and plated exclusively for call or demand service, to modify said vehicle with a meter system and appropriate dome lighting, and to maintain said vehicle; the Commission believes the applicant to lack the requisite level of financial fitness.

For these reasons the application is DISMISSED and DENIED

APPEAL RIGHTS

ALL Parties to proceedings pending before the Commission must open and use an e-filing account through the Commission's website, OR you may submit your filing by overnight delivery. If a filing contains confidential or proprietary material, the filing is required to be submitted by overnight delivery.

If you disagree with this determination, you may send a Petition for Reconsideration of Staff Action to: Secretary, Pennsylvania Public Utility Commission, 400 North Street, Harrisburg, PA 17120. Such a Petition is a written statement asking the Commission to change its determination.

The Petition must be filed with the Commission within twenty (20) days of the date of this letter. If no timely request for reconsideration is made, this action will be deemed to be the final action of the Commission.

The Petition MUST include: (1) a written statement (divided into numbered paragraphs) outlining the reasons for the request, (2) the case docket number(s) (they are provided for you at the top right hand corner of this letter), (3) the name of the person on whose behalf the petition is made, (4) copies of relevant documentation, and (5) a verification with original signature. See 52 Pa. Code §§-1.31 and 5.44.





1. My name is **Jeovanny E. Amparo Mendez**, and I am the authorized representative of Rex-Beni Transportation and Logistics, LLC (“Applicant”). Pursuant to 52 Pa. Code §§ 5.44 and 1.31, I respectfully submit this Petition for Reconsideration of Staff Action regarding the denial of the Applicant’s call or demand authority application.
2. The Commission’s denial, dated August 21, 2025, stated that the Applicant lacked financial fitness, sufficient cash reserves, and essential vehicular equipment.
3. Since the filing of the application, the Applicant has made substantial progress in addressing these concerns:
 - Applicant has **acquired two vehicles** that are fully registered under the company name.
 - Both vehicles are covered by **insurance policies** that meet all PUC requirements.
 - Each vehicle is equipped with **taxi domes**, and a **taximeter is ready for installation** by a technician who is duly authorized by the PUC to perform taximeter installations. The other taximeter is in the process of purchase.
 - Applicant will attach to this Petition copies of the **vehicle registrations, insurance documents, car inspections documents**, and an **updated company bank statement** dated August 01 - August 31, 2025, to demonstrate financial fitness.
4. Applicant further confirms that these vehicles will be used **exclusively for company-authorized taxi transportation** and not for personal purposes.
5. The Applicant believes that these steps directly address the Commission’s concerns and demonstrate both financial fitness and operational readiness to provide safe, efficient, and reasonable service.






