
The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.

NOTE 4 - Minimum Transportation Charge: Sundays and Holidays (any hour): 4 hours plus applicable travel charge at rates named in Columns

1 and 2. Saturdays (any hour) or Weekdays (6:01PM to 5:59AM): 3 hours plus applicable travel charge at rates named in Columns 1 and 4.

Weekdays (6:00AM to 6:00PM): 3 hours plus applicable travel charge at rates named in Columns 1 and 3.

NOTE 5 - When holding the shipment overnight is requested for the convenience of the customer or required by the carrier, a holding fee of

\$200.00 per truck per night will apply in addition to all other applicable charges.

UPRIGHT PIANO - \$150.00 BABY GRAND PIANO - \$225.00 SAFE (250 to 500 pounds) - \$150.00

NOTE AA - Travel charge to be based on the applicable transportation rates shown in Columns 2, 3, and 4 and will apply as follows based on the combined actual road miles from the carrier's terminal to the first point of origin and from the final destination back to the carrier's terminal using Mileage Guide No. 40 or a software program designed to calculate mileage, such as, Google Maps, MapQuest or TruckRouter.

0 - 15 miles	1/2 hour
16 - 30 miles	1 hour
31 - 45 miles	1 1/2 hours
46 - 60 miles	2 hours

For mileage in excess of 60 miles, a travel time charge of 1/2 hour will be assessed for each additional 15 miles.
