Letter: One Week Settlement Conference Extension Request

Complainant does not consent to mediation, but will consent to a one-week, date-certain continuance of the resolution conference to Thursday, September 18, 2025, 11:00am only if,

by September 12, 2025, 5:00pm, Respondent provides:

- the PECO RS-2 ledger (digital format) spring 2024 to present.
- the WGL supply ledger (digital format) spring 2024 to present.
- the \$707.05 / 6,463 kWh month-by-month kWh × rate breakdown.

by September 15, 2025, 5:00pm, Respondent provides:

- Issues a statement regarding August 2025 bill identifying the governing total and reconciling Meter Information vs Usage/Charges/Usage Profile
- Written billing hold conformation (no late fees, termination notices, or credit reporting) during reconciliation.
- Confirmation that a Billing/Net-Metering representative will attend the 9/18/2025 conference.
- Confirmation of the meeting time on 9/18/2025 (default 11:00am, or a mutually agreed time that day).

Absent these conditions, Complainant does not consent to any extension and requests transfer to an Administrative Law Judge for prompt hearing scheduling. For the record, the parties held a telephone resolution conference on August 27, 2025; they agreed a further conference was necessary and tentatively scheduled it for Thursday, September 11, 2025, with Respondent to provide documents and confirmations in advance. To date, Complainant has received neither the promised materials nor confirmation of the follow-up conference.
