On September 9, 2025, PECO Energy Company (PECO) filed a Letter of Notification for approval to construct the 220-80 230 kV Transmission Line and 220-101 230 kV Transmission Line in Montgomery County, Pennsylvania. - A-4 Reference the Letter of Notification, Attachment 2, Item 8. Please provide the approximate date that PECO anticipates the completion of PJM's do no harm analysis.
