The Office of Consumer Advocate, Office of Small Business Advocate, and the Department of Environmental Protection's central and regional offices.

You are directed upon receipt of this letter to publish the enclosed notice once a week for two consecutive weeks in a newspaper having a general circulation in the area involved and file proof of publication with the Commission on or before October 13, 2025.

Pursuant to 52 Pa. Code §5.14, the Commission will proceed with publishing the attached notice in the Pennsylvania Bulletin. This notice will appear in the September 27, 2025, issue.


