Yes, I will be exclusively hiring PUC's certified passenger carriers.

As a broker, I will ensure that all transportation contractors engaged under this brokerage maintain an active Certificate of Public Convenience (CPC) or permit issued by the PUC. Prior to entering into any agreement, contractors will be required to submit proof of their current CPC/permit, which will be independently verified through the PUC's public records.

To maintain ongoing compliance, I will establish and update a contractor compliance log containing each contractor's CPC/permit number, effective dates, and expiration dates. Renewal reminders will be issued at least 60 days prior to expiration, and contractors will be required to provide updated documentation before the renewal deadline.

All contracts will include a requirement that contractors maintain a valid CPC/permit at all times, notify the broker immediately of any lapse, suspension, or revocation and understand that failure to do so will result in suspension from trip assignments until compliance is restored. Periodic audits will also be conducted by verifying contractor status directly with the PUC.

Enforcement procedures will consist of suspended assignment of trips to any contractor whose CPC/permit cannot be verified or has lapsed and a corrective action process will be established where contractors must resolve issues before reinstatement.

This process ensures that only fully authorized and compliant transportation providers are utilized, protecting the public and maintaining adherence to all regulatory requirements.
