Dear Sir or Madam:

On behalf of Resource Energy Solutions, LLC, A-2019-3008951 and A-2020-3021871 (the "Licensee"), this letter provides formal notice to the Pennsylvania Public Utility Commission (the "Commission") of a transaction occurring on September 4, 2025 whereby Conservice Parent, LLC, and its affiliates ("Buyer"), acquired 100% of the equity interests of Licensee (hereinafter, the "Transaction").

Licensee respectfully requests the Commission's approval of the Transaction and confirmation that the existing licenses of Licensee will remain in full force and effect without further amendment following the Transaction. Notably, the Transaction will not change the fact that Resource Energy Solutions, LLC is the licensed entity providing energy services to customers and the Transaction will not modify Licensee's day-to-day operations, and all personnel will remain unchanged. Licensee's F-EIN also remains the same. Accordingly, the Transaction will not affect the services provided to the Licensee's customers.

In addition, Buyer is experienced with providing the same types of services as provided by Licensee. Buyer has dedicated regulatory compliance personnel with 25 years of energy procurement experience. Buyer is experienced with all applicable statutes, rules, and reporting obligations of Licensee. Buyer and Licensee have the financial and technical experience to effectively service the Licensee's customers after the Transaction. Accordingly, Licensee respectfully requests that the Commission approve the Transaction as described herein.




