MOTOR CARRIER COMPLAINT

The Pennsylvania Public Utility Commission (Commission or “PUC”) is a duly constituted agency of the Commonwealth of Pennsylvania empowered to regulate public utilities within the Commonwealth. The Commission has delegated its authority to initiate proceedings which are prosecutory in nature to the Bureau of Investigation and Enforcement and other bureaus with enforcement responsibilities. Pursuant to that delegated authority and Section 701 of the Public Utility Code, the Bureau of Investigation and Enforcement -Motor Carrier Division hereby represents as follows:

1. That RT EXPEDITE TRANSPORT LLC, Respondent, maintains a principal place of business at 120 Charles Drive, Windsor, PA 17366.
2. That on March 21, 2025, by Commission Secretarial Letter, Respondent was issued a certificate of public convenience by this Commission authorizing transportation, as a common carrier, by motor vehicle, property, excluding household goods in use, between points in Pennsylvania.at Application Docket No. A-2025-3053989, PUC Utility Code 8927813.
3. That PUC Enforcement Officer Matthew Ohlinger was assigned to conduct a Safety Fitness Review (“SFR”) and initiated a series of attempts to contact the Respondent and received no response. On August 19, 2025, Respondent was mailed a letter urging compliance with the 180-day requirement in receiving a satisfactory SFR rating. The letter provided a 10-day deadline for Respondent to schedule a SFR.
4. That Respondent, by failing to appear for a review and achieve a satisfactory SFR evaluation while certificated by this Commission as a common carrier, violated 66 Pa. C.S. §§501(c),504. The penalty for these violations is cancellation of the certificate held by Respondent with this Commission at PUC Utility Code 8927813.

WHEREFORE, the Bureau of Investigation and Enforcement hereby requests that the Commission revoke the certificate of public convenience issued to RT EXPEDITE TRANSPORT LLC, at PUC Utility Code 8927813.
