



Section 2: Plans and policies for expansion of company after receiving the Certificate of Public Convenience

Hiring Standards for drivers; (Title 52 PA Code 29.503)

Valid Driver's License

- All Drivers must have a valid, PA state-issued driver's license.

Age Requirements

- The minimum age of any new driver is 21 years old.

Clean Driving Record

- All Drivers must have a clean driving record.
- Any new hires would need to produce a driving history document from the past three years in all states they have provided driving services.
- If hired, the driver will need to provide an Annual Driving History Record.
- All Records will be kept and maintained in a Driver Profile Record Filing System.

Background Check

- A criminal history background check is mandatory prior to hire.
- Convictions for violent crimes, drug offenses, DUI's, or sexual offenses will disqualify the candidate.
- If the candidate passes the criminal history background check and is hired, a new background check will be required every two years.
- All records will be kept and maintained in a Driver Profile Record Filing system.

Drug and Alcohol Policies

- Drug and Alcohol use is not permitted while operating a vehicle under the company name at any time.

1) Criminal Background Check Process

- a) New Candidates that live in PA will be required to take a criminal background check through PATCH - <https://epatch.pa.gov/>
- b) If a new candidate has lived in another state and provided driving services in that state, an out of stand criminal background check will be required.
- c) All reports will comply with the PUC requirements for background checks.
- d) Once a candidate passes the background check, is hired, there will be a 2 year background check that will be required.

- i) Example: If new driver is hired on October 1, 2025 (Background check was completed prior to October 1)
 - (1) The next background check will be required by October 1, 2027
- e) Disqualifying a Driver:
 - i) If any new candidate shows a record of criminal history such as, Theft, DUI, Sexual Offenses, or Violent Crimes, that candidate will be immediately disqualified from moving further into the hiring process.
- f) Maintaining Records: All candidates (hired or not hired) will have a Driver Profile File, that will include a section for the Background Checks. These files will be stored locally at the business in a confidential area as well as electronically.

2) Driving Training Program for Prospective Drivers

(1) Training Requirements (1057.8)

- a) Regulations governing limousine drivers, certificate holders, equipment, and penalties for violations.
- b) Overview of the administrative process connected to violations.
- c) Driving & customer safety issues, e.g. defensive driving, emergency aid, vehicle and equipment inspections, crime prevention, accident reporting
- d) Geographic / navigational knowledge of the Pittsburgh area and townships the company will service; map reading, major street & traffic patterns, identifying landmarks.
- e) All training material will be printed and given to the driver to keep and will be marked as a completed training in their Driver Profile electronically.

(2) Testing Requirement (§ 1057.9)

- a) A new driver will be required to take a written test and demonstration test.
- b) The written test will have written and multiple choice questions.
- c) The driver will also be interviewed (verbal exam).
- d) The driver will be required to conduct a live demonstration of driving with the owner in the car to approve the test.
- e) The driver will have a maximum of 3 attempts to pass a demonstration test.

(3) Driver License Verification (History Checks)

- a) New applicants will need to provide a photo of their current driver license.
- b) We will obtain an MVR for each driver prior to hiring.
- c) We will obtain MVR annually if a driver is hired.
- d) We will use PennDOT to conduct the license check and history.
- e) The license checks will be conducted annually for each driver.

- f) All license check information will be stored in the Driver Profile filing system in the license check section; as well as, electronically.

(4) Alcohol and Drug Policies

- a) The company will maintain a strict zero-tolerance policy for alcohol and drug use.
- b) All drivers must pass a pre-employment drug screening and are subject to random, post-accident, and reasonable suspicion drug and alcohol testing in accordance with DOT guidelines.
- c) The use, possession, or influence of drugs or alcohol while on duty is strictly prohibited.
- d) Any violation of this policy will result in immediate termination and may be reported to the appropriate authorities.
- e) All information will be stored in the Driver Profile System as well as electronically.


