**ORDER  
TERMINATING NEGOTIATIONS WITH SETTLEMENT JUDGE  
AND REFERRING PROCEEDING TO ADJUDICATORY JUDGE**

By Order dated November 25, 2024, the Office of Consumer Advocate’s unopposed request for the assignment of a separate Settlement Judge was granted by Chief Administrative Law Judge Charles E. Rainey, Jr. This Order assigned the undersigned administrative law judge (ALJ) to serve as the settlement judge, and if the matter did not settle, adjudicatory judges Eranda Vero and Arlene Ashton would adjudicate the proceeding. By a Judge Change Notice dated March 28, 2025, ALJ Vero is the sole adjudicatory judge.

This matter has not settled and on September 19, 2025, the parties have requested a prehearing conference in order to discuss a possible litigation schedule and other procedural matters. After the undersigned’s consultation with, and approval of the Chief ALJ, this matter will be referred to the adjudicatory ALJ for further proceedings and resolution.

IT IS ORDERED:

1. That the settlement negotiations with the undersigned Settlement Judge are terminated.

2. That this proceeding is referred to the adjudicatory Administrative Law Judge, Eranda Vero, for adjudication of this matter.
