Enclosed for filing with the Pennsylvania Public Utility Commission is the request to discontinue service granted at Docket No. A-2024-3051389, which authorized Chalfont Transportation Services Inc *“To transport, as a common carrier, by motor vehicle, persons in Paratransit service from points in the City and County of Philadelphia, to points in Pennsylvania and return.”* The reason is that Chalfont has been granted expanded authority at Docket A-2025-3054702 that includes the authority quoted above; *“To transport, as a common carrier, by motor vehicle, persons in paratransit service, from points in the Counties of Bucks, Chester, Delaware, Lehigh, Montgomery, Northampton, and the City and County of Philadelphia to points in Pennsylvania, and return.”* Upon the approval of the later granted authority the prior authority can be withdrawn.


4. This application is for the discontinuance of Part

Wherefore, Applicant requests the Commission to cancel, or amend the certificate of public convenience, as now held, in conformance with the application.


