



PINE ROAD SOLAR PARTNERS FOR LEAVE
TO WITHDRAW FORMAL COMPLAINT**

NOW COMES Pine Road Solar Partners (“Pine Road”), by and through its Counsel, HMS Legal LLP, pursuant to 52 Pa. Code § 5.94(a), and hereby Petitions the Pennsylvania Public Utility Commission to withdraw its Formal Complaint in the above-captioned matter. The Formal Complaint was filed with the Commission on January 31, 2025, and over the objection of Pine Road was directed to mediation. At this point, the relief requested in the Complaint has become unavailable and the work on the project that was the subject of the Complaint has been completed, albeit several months later than expected. At this point, there does not appear to be any reason to pursue the Complaint, but nonetheless, Pine Road reserves the right to refile this Complaint at some future point if necessary, and requests to withdraw the Complaint without prejudice.
