**INTERIM ORDER  
GRANTING FOURTH REQUEST FOR A CONTINUANCE**

Continuances were granted on June 16, 2025, and July 7, 2025, and July 24, 2025, in order to provide the parties to pursue potential resolution of their dispute.

On September 16, 2025, counsel for Peoples filed a status report noting that Peoples and the Complainant continue to work toward resolving the complaint but need additional time to complete a construction project to ensure that the Complainant’s issues are adequately addressed. Therefore, Peoples requested a further continuance. The Complainant did not object.

THEREFORE,

IT IS ORDERED:

1. That Peoples’ request for a continuance is granted.
2. That on or before **October 6, 2025**, counsel for Peoples shall **file** a joint status report that provides an update and recommends further proceedings. If the parties recommend that this matter be set for hearing, the status report shall include three alternative dates when both parties and their witnesses are available for hearing.

3. In the event that a certificate of satisfaction is filed no status report shall be necessary.
