**ORDER DIRECTING PUBLICATION OF NOTICE OF
PREHEARING CONFERENCE**

On August 8, 2025, Mid-Atlantic Interstate Transmission, LLC (MAIT or Applicant) filed an Application pursuant to 52 Pa. Code 57.74(c). The project proposes to construct approximately 12.9 miles of 230 kilovolt (kV) transmission line by rebuilding the existing 115 kV and 138 kV transmission lines between the Pennsylvania-Maryland border and Hunterstown Substation to double-circuit 230/115 kV and 230/138 kV lines, respectively. The proposed Carroll-Hunterstown 230 kV Transmission Line will cross 12.9 miles in Straban, Mount Pleasant, Mount Joy, and Germany townships in Adams County, Pennsylvania. It is proposed to be constructed within an existing transmission corridor, which is currently occupied by the Carroll-Germantown 138 kV, Germantown-Lincoln 115 kV, Lincoln-Riley 115 kV, and Riley-Hunterstown 115 kV transmission lines. The Carroll-Hunterstown 230 kV Transmission Line is needed to increase the current carrying capacity of the existing Carroll-Hunterstown corridor that connects Hunterstown Substation in Adams County, Pennsylvania to Carroll Substation in Carroll County, Maryland to meet current and expected transmission system needs in Adams and Carroll counties and surrounding areas. Construction on the Carroll-Hunterstown Improvements Project is scheduled to begin on or about April 1, 2027, subject to Commission approval, to meet an in-service date of June 1, 2028. MAIT has requested that the Commission issue a final ruling in this matter by January 2027.

A telephonic prehearing conference has been scheduled in this proceeding for **November 24, 2025**, beginning at **10:00 a.m.**

This Order directs Mid-Atlantic Interstate Transmission, LLC to publish notice of the prehearing conference and the deadline for the filing of protests and petitions to intervene in newspapers of general circulation in the areas including in this application once per week for two consecutive weeks prior to the date of the prehearing conference, consistent with the Pennsylvania Public Utility Commission's regulations and the ordering paragraphs below. The first notices shall be published at least **45 days prior to the prehearing conference** scheduled for **November 24, 2025**, and the second notices shall be published not later than **7 days after the first notices** are filed.

Proof of publication shall be filed with the Secretary with a copy provided to the undersigned presiding officers.

Accordingly, the following Order will be entered.

THEREFORE,

IT IS ORDERED:

1. That Mid-Atlantic Interstate Transmission, LLC shall publish notices of the prehearing conference and deadline for the filing of protests and petitions to intervene in newspapers of general circulation in the areas included in this application once per week for two consecutive weeks prior to the date of the prehearing conference. The first notices in each publication shall be published at least 45 days prior to the prehearing conference scheduled for November 24, 2025, and the second notices shall be published not later than 7 days after the first notice is published. The Notices shall be published in the newspapers of general circulation in the areas where the proposed transmission lines exist, are to be constructed, and/or are to be rebuilt, including Straban, Mount Pleasant, Mount Joy, and Germany Townships, which are located in Adams County, Pennsylvania.

2. That said Notices shall also include the address and electronic addresses to apprise the public regarding how and where protests and petitions to intervene may be filed and where to provide Mid-Atlantic Interstate Transmission, LLC with a copy of protests and petitions to intervene in this proceeding.

3. That said Notices shall also include the address where the public may obtain information from Mid-Atlantic Interstate Transmission, LLC related to the filing, and a statement identifying the filing, the date on which the filing was made, a description of the proposed project and action to be taken, and a description of how and where the Application is available for public examination.

4. That Mid-Atlantic Interstate Transmission, LLC shall file proofs of publication with the Secretary of the Pennsylvania Public Utility Commission and serve a copy on the presiding officers, within two weeks of publication.
