ORDER
DENYING MOTION TO EXCLUDE UNRELIABLE AND INADMISSIBLE EVIDENCE

On October 7, 2024, Jaycinah Simon (“Ms. Simon” or “Complainant”) filed a Formal Complaint (“Formal Complaint”) against Philadelphia Gas Works (“PGW” or “Respondent”) with the Pennsylvania Public Utility Commission (“Commission”), alleging that PGW was threatening to or has already shut off her service, that she would like a payment arrangement, and that there were incorrect charges on her bill. On November 7, 2024, PGW filed an Answer with New Matter to the Complaint.

An evidentiary hearing is scheduled in this matter for October 2, 2025, at 10:00 a.m.

On September 26, 2025, PGW submitted proposed exhibits to me and Ms. Simon.

On September 29, 2025, Ms. Simon filed a Motion to exclude unreliable and inadmissible evidence. Ms. Simon’s Motion is in essence a Motion in Limine wherein Ms. Simon seeks to exclude PGW’s exhibits from admission into the record. The Motion was not served on the undersigned, and the Motion does not contain a certificate of service that indicates that it was served on PGW. I caused the Motion to be served on PGW on October 1, 2025.

The admissibility of PGW's proposed exhibits cannot be determined at this time. The exhibits submitted by PGW on September 26, 2025, are exhibits that PGW proposes to present at the hearing. PGW has not yet had the opportunity to present testimony from its sponsoring witness(es) to show that the evidence is authentic, reliable, and relevant. Ms. Simon may object to the admission of PGW's exhibits when PGW moves to admit its exhibits into the record during the evidentiary hearing.

Ms. Simon's Motion will be denied in the Ordering paragraphs below.

ORDER

THEREFORE,

IT IS ORDERED:

1. That Jaycinah Simon's Motion to exclude unreliable and inadmissible evidence, filed on September 29, 2025, in the matter of Jaycinah Simon v. Philadelphia Gas Works, Docket No. F-2024-3051634, is denied.
