**Re: Pennsylvania Public Utility Commission v. PPL Electric Utilities Corporation
Docket No. R-2025-3057164**

Dear Secretary Homsher:

Enclosed for filing on behalf of PPL Electric Utilities Corporation (“PPL Electric” or the “Company”) is Original Tariff Electric – Pa. P.U.C. No. 202 (“Tariff No. 202”) seeking a general rate increase pursuant to 66 Pa. C.S. § 1308(d) of the Public Utility Code. Tariff No. 202 sets forth proposed rates designed to produce an increase in PPL Electric’s annual base rate distribution revenue of approximately \$356 million based on data for a Fully Projected Future Test Year ending June 30, 2027. Tariff No. 202 contains other changes to certain rules and regulations, rate schedules, and riders in the Company’s currently-effective Retail Electric Service Tariff, Tariff Electric – Pa. P.U.C. No. 201. Those changes are summarized in PPL Electric Exhibit GEO-2. Furthermore, PPL Electric is submitting Original Tariff Electric – Pa. P.U.C. No. 2S (“Tariff No. 2S”), which is the Company’s proposed Electric Generation Supplier Coordination Tariff and sets forth the Company’s rules, regulations, charges, and riders for its provision of coordination services to electric generation suppliers (“EGSs”). A summary of the proposed changes to the existing Electric Generation Supplier Coordination Tariff, Tariff Electric – Pa. P.U.C. No. 1S, is provided in PPL Electric Exhibit LN-2.

Tariff No. 202 and Tariff No. 2S bear an issued date of September 30, 2025, and an effective date of December 1, 2025. PPL Electric requests that any suspension of Tariff No. 202 and Tariff No. 2S by the Pennsylvania Public Utility Commission (“PUC” or the “Commission”) contemplate the entry of a Final Order disposing of them at the June 4, 2026 public meeting.

Along with Tariff No. 202 and Tariff No. 2S, the Company is filing all the supporting data required by the Commission's regulations at 52 Pa. Code §§ 53.52-53.53, including the written direct testimony of 22 witnesses, who are identified in PPL Electric Statement No. 1. Below is an index of the volumes provided with this filing:

A summary of the reasons for the proposed rate increase is set forth in the Company's Statement of Reasons, which accompanies this filing.

The Company is filing two electronic copies of its entire filing: one electronic copy of the entire filing is being submitted via the PUC's SharePoint site, and another electronic copy of the entire filing is being provided on a USB flash drive submitted to the Secretary's Bureau.

PPL Electric hereby advises the Commission that it has elected to use the alternative method of customer notification set forth in the Commission's regulations at 52 Pa. Code § 53.45(b)(4). As required by that regulation, PPL Electric will notify its customers of the proposed rate in bill inserts along with paid advertisements in major local newspapers. The Company further agrees to extend from 60 to 90 days the minimum period within which the filing of a complaint places the burden of proof upon the Company with respect to proposed rates, pursuant to 52 Pa. Code § 53.45(b)(4)(vi).
