**INTERIM ORDER**  
**GRANTING ADMISSION OF JOINT STIPULATION OF FACTS INTO THE RECORD AND**

On September 26, 2025, Aqua Pennsylvania, Inc. (Aqua, or the Company), serving as the Receiver for Venango Water Company (VWC), Cooperstown Water Company (CWC), Fryburg Water Company (FWC), Plumer Water Company (PWC), Sugarcreek Water Company (SWC), and West Hickory Water Company (WHWC) (collectively, the “Rhodes Water Utilities”), the Office of Consumer Advocate (OCA), and the Office of Small Business Advocate (OSBA) (Stipulating Parties), all parties to the above-captioned proceeding, filed a Joint Stipulation of Facts (Stipulation) in the above-captioned proceeding. Each of the Stipulating Parties stipulated to the veracity and authenticity of the facts set forth in the Stipulation and requested that the Stipulation be admitted into the record of this proceeding on the terms and conditions set forth in the Stipulation.

As the request of the Stipulating Parties is reasonable, the request will be granted.

2. That, following the admission of the Joint Stipulation of Facts referenced in Ordering Paragraph 1, above, the evidentiary record for this proceeding is closed.
