Enclosed is a **RATE CHANGE** for the existing exception tariff, Tristate 54, effective November 3<sup>rd</sup>, 2025, for A Action Family Moving Company, Inc., t/a Transtar Moving Systems (PA PUC Certificate #A-00113642) in Moorestown NJ.

The attached pages are 731<sup>st</sup> Revised Page 2, 301<sup>st</sup> Revised Page 2-A, 118<sup>th</sup> Revised Page 5, 8<sup>th</sup> Revised Page 11-H, 1<sup>st</sup> Revised Page 11-H-1, and Original Page 11-H-2.

This filing is for an **INCREASE** in local hourly rates, a **CHANGE** in the application of travel time charges, the **ADDITION** of one-quarter hour increments for local moves, an **INCREASE** in the overnight holding fee, the **ADDITION** of exceptions for shipments transported in excess of 40 miles, an **INCREASE** in carton prices & packing labor rates, and the **ADDITION** of a packing material delivery charge for distances over 40 miles.


The insurance information on the PA PUC website was checked and it appears that insurance forms E and H are in compliance.
