In accordance with the Interim Order issued on September 2, 2025 in the above-referenced matter, this letter serves as the status report of FirstEnergy Pennsylvania Electric Company on behalf of its Penelec Rate District. The Company provided its initial witness identification on January 4, 2019. Please note that the Company's witnesses have since changed. The Company anticipates that it will need to present two witnesses, John C. Ahr and Dr. Mike Israel, in order to rebut any testimony offered at that time.

Based upon this information, the Company believes that the above-referenced proceeding is ready to proceed to an evidentiary hearing. The September 2, 2025 Interim Order requires the parties to discuss available hearing dates. The Company contacted the Complainant on September 17, 2025 electronically but was unable to reach the Complainant to discuss hearing dates for a January or February 2025 hearing. The Complainant submitted her status report dated September 25, 2025 and proposed February 20, 24 and 27, 2026 as possible hearing dates. The Company and its witnesses are currently available for the dates suggested by the Complainant.


