MOTION FOR CONTINUANCE OF HEARING

Complainant, Gabriel Byan, respectfully requests a continuance of the initial telephonic hearing currently scheduled in this matter, and in support thereof states as follows:

1. The above-captioned case is presently scheduled for an **Initial Telephonic Hearing on Friday, October 10, 2025, at 10:00 a.m.** before Administrative Law Judge Eranda Vero.
2. Pursuant to Paragraph 3 of the Prehearing Order dated August 13, 2025, continuances may be granted upon good cause shown if requested at least five (5) business days prior to the hearing.
3. Complainant requests a continuance for the following reason:
 - o I have a scheduling conflict at the originally scheduled time. Moreover, when I called to inquire about how to submit exhibits for my hearing, I was instructed that I would be given guidance at the time of my hearing by the administrative law judge on how it should be submitted. This may have been a misunderstanding or miscommunication, but I recently realized that the information I had been supplied verbally did not comport fully with some indications in my prehearing order. I realized this upon receipt of submissions by PECO's attorneys, which I noticed hours before the end of the business day I would need to review and submit my documents and records. As I need sufficient time to organize and properly submit records for consideration by all parties, and to get further guidance on audio files and potential handling of confidential information, I hereby request a continuance so that I can have adequate time to gather, redact, and present evidence in this trial and serve it appropriately upon all parties.
4. Counsel for PECO Energy Company has previously approved a continuance request I made to them.

5. This request is made in good faith and for the purpose of fairness. A short continuance will permit the parties to more fully prepare their evidence, promote judicial efficiency, and avoid prejudice.

WHEREFORE, Complainant respectfully requests that the Initial Telephonic Hearing scheduled for October 10, 2025, be continued to a later date convenient to the Court and the parties.
