**INTERIM ORDER  
GRANTING FIFTH REQUEST FOR A CONTINUANCE**

Continuances were granted on June 16, 2025, and July 7, 2025, and July 24, 2025, September 29, 2025, to provide the parties to pursue potential resolution of their dispute.

On October 2, 2025, counsel for Peoples filed a status report noting that Peoples and the Complainant continue to work toward resolving the complaint but need additional time to complete a construction project to ensure that the Complainant’s issues are adequately addressed. Peoples reports that the mainline extension necessary to split the service at the property from one shared customer-owned service line into two, is under way and Peoples expects to complete the work within the next two weeks. Peoples has been communicating with the Complainant and the adjoining property owner, to ensure customer-side plumbing and ancillary work will be ready to make the new connection. Therefore, Peoples and the Complainant requested further continuance.

THEREFORE,

IT IS ORDERED:

1. That the joint request for continuance is granted.

2. That on or before **October 17, 2025**, counsel for Peoples shall **file** a joint status report that provides an update and recommends further proceedings. If the parties recommend that this matter be set for hearing, the status report shall include three alternative dates when both parties and their witnesses are available for hearing.

3. In the event that a certificate of satisfaction is filed no status report shall be necessary.
