AND NOW COMES Christopher Old, by his undersigned counsel and requests a continuance of the scheduled October 8, 2025 hearing date, representing as follows:

1. The August 25, 2025 Pre-hearing Order for Teelephone Hearing schedules a hearing in the above captioned matter on October 8, 2025.

2. Today, October 3, 2025 Mr. Old retained undersigned counsel to represent him at this hearing. Counsel has prepared and will be filing a Notice of Appearance.

3. The aforementioned Pre-Hearing Order states, inter alia, that any request for a continuance shall be made "at least five days before the hearing" Order par 3.

4. The Pre-Hearing Order also states that any exhibits shall be submitted "at least five business days before the hearing."

5. In as much as counsel has just been retained to represent Mr. Old, counsel has not had an opportunity to review any exhibits submitted by Duquesne Light Company and has not determined whether any exhibits will be submitted on behalf of Mr. Old.

6. Counsel has had an opportunity to speak with counsel for Duquesne Light and advised Duquesne Light's attorney that he will be submitting the Notice of Appearance and a Request for a Continuance.

7. Counsel for Mr. Old is also in receipt of an email from Judge DeVoe to Mr. Old sent this afternoon.




