Dear Secretary, Homsher,

In response to the Data Request Letter dated September 25, 2025, regarding the application of Rampart Care LLC t/a Rampart Home Care for motor carrier authority, please find the following information:

1. Operations Explanation

Rampart Care LLC intends to operate as a non-emergency medical transportation (NEMT) and paratransit carrier.

Our services will be available to:

- 1. Private Clients** – Individuals enrolled in Rampart Home Care services who require transportation to medical, therapy, pharmacy, and other health-related appointments.
- 2. The General Public** – Individuals in the community needing safe, reliable, and pre-scheduled non-emergency transportation for medical, health-related, and essential activities.

Planned Service Model:

- Advance-scheduled, origin-to-destination trips only (no taxi or street hail services).
- Service area includes Philadelphia County and surrounding counties, with longer trips

permitted as medically necessary.

- Trips booked by phone, online, or through contracts with potential Medicaid brokers, insurers, and healthcare partners.

- **Payment sources:** managed care organizations (MCOs), private insurers, and private pay.

- Vehicles company-owned or leased, inspected and maintained to DOT standards, operated by trained and qualified drivers.

2. Driver Compliance Policies (Title 52 Pa. Code § 29)

Rampart Care LLC has adopted the following driver qualification standards to ensure safety for both private clients and members of the general public:

§29.503 – Age Restrictions

- Drivers must be at least 21 years old.

- No maximum age restriction if the driver maintains medical clearance and a clean record.

§29.504 – Driver History

- A Motor Vehicle Record (MVR) will be obtained for all drivers covering the last 10 years prior to hire.

- Annual MVR checks will be conducted.

- Drivers with serious violations (DUI, reckless driving, hit and run) will not be hired or permitted to operate.

- New violations must be reported immediately and reviewed by management.

§29.505 – Criminal History

- All drivers will undergo a PA State Police background check and FBI clearance.

- Criminal histories will be evaluated to ensure passenger safety.

- Records will be kept confidential and retained during employment plus three years after separation.

Monitoring & Recordkeeping

- A qualification file will be maintained for each driver.

- Records will include MVRs, background checks, training certifications, and medical clearances.

- Annual reviews will ensure compliance with safety standards.

Public Safety Commitment

- Drivers will receive initial and ongoing training in defensive driving, passenger assistance, and sensitivity training.
- Vehicles will undergo regular safety inspections and preventive maintenance.




