INTERIM ORDER
LATE-FILED EXHIBITS

An Initial Telephonic Hearing was held on October 8, 2025 at 10:00 a.m. The hearing convened as scheduled with both parties in attendance. At the hearing, Artem Shyrshykov (“Complainant”) introduced 25 Complainant Exhibits for the record. THEREFORE;

IT IS ORDERED:

1. That PPL Electric Utilities Corporation shall raise any objections to Complainant's Exhibits 1 through 25, attached hereto as Appendix A, in writing on or before October 20, 2025.
2. That if an objection is filed, Complainant, Artem Shyrshykov, shall have ten days from the filing of the objection to file a response.
3. That if no objection is made, Complainant Exhibits 1 through 25 are admitted into the record for Artem Shyrshykov v. PPL Electric Utilities Corporation at Docket No. C-2025-3054075.
