
3. By Secretarial Letter dated December 24, 2024, the Pennsylvania Public Utility Commission (Commission) granted PECO’s application and directed that “[t]he alteration of the crossing be completed on or before October 31, 2025.”

4. Due to permitting issues, PECO now projects that it will be unable to complete the work by the determined deadline on or before October 31, 2025.

5. Accordingly, PECO respectfully requests an extension of time to complete the alternation of the crossing from the October 31, 2025 due date set forth in the Secretarial Letter to an extended date of October 31, 2026, and that Paragraph 8 of the Secretarial Letter, dated December 24, 2024, be modified as follows:

The alteration of the crossing be completed on or before ~~October 31, 2025~~ October 31, 2026, and that on or before said date PECO Energy Company, report in writing the date of actual completion of the work to this Commission and certify to the parties of record and this Commission that the work has been satisfactorily completed in accordance with the approved plans and this Secretarial Letter.

WHEREFORE, PECO Energy Company, requests that the Commission's Secretarial Letter, dated December 24, 2024, be modified consistent with this Petition.


