**ORDER REGARDING RESPONDENT’S REQUEST
FOR A CONTINUANCE OF THE HEARING**

By email dated October 3, 2025, counsel for UGI Utilities, Inc. (UGI) requested the continuance of the hearing scheduled for October 22, 2025, at 10:00 a.m. in the above-captioned matter. As reason for requesting the continuance, counsel cited a conflict in her schedule. In addition, counsel averred that she had attempted to communicate with Ms. Bedford regarding UGI’s need to reschedule hearing but was unable to reach her.

By email dated October 10, 2025, I informed the parties in this case that I would grant UGI’s request for continuance.

A few minutes later, Michelle Bedford contacted me via email and objected to UGI’s request for continuance.

Pursuant to Commission regulation at 52 Pa. Code § 1.15(b) timely requests for continuance of hearings may be granted if good cause is shown for the continuance.

Upon considering both parties’ positions, I find that UGI’s counsel’s unavailability on the date set for the hearing constitutes a good cause for granting the request and continuing the hearing for a later date.

The evidentiary hearing scheduled for October 22, 2025, will be cancelled and a new hearing date will be set in the future.

THEREFORE,

IT IS ORDERED:

1. That UGI Utilities, Inc.'s request for continuance of the scheduled hearing is granted.
2. That the evidentiary hearing scheduled for October 22, 2025, in the matter of Matterns Floral Co. LLC c/o Michelle Valentino Bedford v. UGI Utilities, Inc. at Docket Nos. C-2025-3056200 and C-2025-3056208 is cancelled.
3. That a new hearing date will be set in the future
