

**MOTION OF DUQUESNE LIGHT COMPANY TO  
DISMISS THE FORMAL COMPLAINT OF TONYA LEE BROWN**

---

TO ADMINISTRATIVE LAW JUDGE MARY D. LONG:

Pursuant to 52 Pa. Code §§ 5.371-5.372, Duquesne Light Company (“Duquesne Light” or the “Company”) hereby files this Motion to Dismiss the Formal Complaint filed by Tonya Lee Brown (“Complainant”) in the above-captioned proceeding, because: (1) the Commission lacks subject matter jurisdiction due to the Complainant’s active Chapter 7 bankruptcy proceeding at Case No. 25-20265-JAD; and (2) the Complainant failed to appear for the hearing scheduled for October 7, 2025, and prosecute her Complaint.

In support of its Motion, Duquesne Light states as follows:

**I. INTRODUCTION**

1. Duquesne Light is a “public utility” and an “electric distribution company” as defined in Sections 102 and 2803 of the Pennsylvania Public Utility Code, 66 Pa.C.S. §§ 102, 2803.

2. On or about July 30, 2024, the Company was served with the above-captioned Complaint filed by Tonya Lee Brown via Secretarial Letter from the Commission (“Complaint”).

In the Complaint, the Complainant requested a new payment arrangement and alleged that she was eligible for the Company's Customer Assistance Program ("CAP").

3. On August 19, 2024, Duquesne Light timely filed an Answer to the Complaint, admitting in part and denying in part the factual basis of the Complainant's allegations.

4. On August 21, 2024, the Commission issued an Initial Call-In Telephonic Hearing Notice, scheduling an evidentiary hearing for the Complaint for November 7, 2024, before Administrative Law Judge Mary D. Long (the "ALJ").

5. Also on August 21, 2024, the ALJ issued a Prehearing Order confirming the date and time of the evidentiary hearing for the Complaint.

6. On November 1, 2024, Duquesne Light filed a motion to continue the hearing because the Company's witness was unavailable. By email on November 4, 2024, the Complainant stated that she agreed with the request for a continuance. The ALJ canceled the November 7, 2024, hearing and notified the parties that a continuance had been granted.

7. On December 9, 2024, the Commission issued a second Initial Call-In Telephonic Hearing Notice, rescheduling the evidentiary hearing for February 19, 2025.

8. On February 3, 2025, the Complainant filed a petition for bankruptcy with the U.S. Bankruptcy Court for the Western District of Pennsylvania at Case No. 25-20265-JAD, which was ultimately categorized as a Chapter 7 bankruptcy petition ("Chapter 7 Petition"). True and correct copies of the Complainant's initial bankruptcy petition, Duquesne Light's related Proof of Claim, and the Chapter 7 Petition Docket Sheet are attached hereto as **Appendices A through C**, respectively.

9. On February 17, 2025, Ms. Brown requested a continuance due to the pending Chapter 7 Petition. Duquesne Light did not object to this request.

10. On February 18, 2025, the ALJ canceled the hearing scheduled for February 19, 2025, and notified the parties that a continuance had been granted. Duquesne Light was directed to file a status report by April 4, 2025.

11. On April 4, 2025, Duquesne Light submitted a status report notifying the ALJ that the Complainant had informed Duquesne Light that her bankruptcy petition was still pending and reporting that the Complainant was requesting an additional 90-day continuance. Duquesne Light did not object to this continuance request.

12. On April 8, 2025, the ALJ filed an Interim Order Granting Motion For Continuance (“Interim Order”). The Interim Order required Duquesne Light to file a joint status report that provided an update on or before July 8, 2025.

13. On July 8, 2025, Duquesne Light submitted a status report pursuant to the Interim Order. The status report stated that the Complainant’s bankruptcy petition remained pending and notified the ALJ that the Complainant requested an additional continuance of the hearing for this matter. Duquesne Light did not agree to an additional continuance of this matter.

14. On July 10, 2025, the ALJ denied the Complainant’s further request for a continuance.

15. On July 10, 2025, the Commission issued a third Initial Call-In Telephonic Hearing Notice, scheduling an evidentiary hearing for the Complaint for Tuesday, October 7, 2025.

16. On October 1, 2025, Duquesne Light served its exhibits to be used for the October 7, 2025, hearing on the Complainant via email and Federal Express.

17. The Complainant requested an additional continuance of the hearing due to her pending Chapter 7 Petition via emails sent on September 30 and October 6, 2025, which Duquesne Light opposed.

18. The ALJ did not grant the Complainant's additional continuance requests and informed the parties via email dated October 6, 2025, that the hearing would convene as scheduled on October 7, 2025.

19. As scheduled, counsel for Duquesne Light appeared at the October 7, 2025, hearing by telephone. However, the Complainant failed to appear. The Complainant had ample notice of the scheduled conference, and the hearing notice noted that failure to appear by telephone for the status conference could result in the case being dismissed.

20. For the reasons explained herein, Duquesne Light respectfully requests that the ALJ grant the instant Motion and dismiss the Complainant's Formal Complaint with prejudice, because the Commission lacks subject matter jurisdiction due to the Complainant's active Chapter 7 Petition and due to the Complainant's failure to appear for the scheduled hearing and prosecute her Complaint.

## **II. MOTION TO DISMISS**

### **A. THE COMMISSION LACKS SUBJECT MATTER OVER THE COMPLAINT BECAUSE THE COMPLAINANT HAS AN ACTIVE BANKRUPTCY PROCEEDING**

21. The Complaint should be dismissed because the Commission lacks subject matter jurisdiction due to the Complainant's active Chapter 7 Petition.

22. "Generally any bankruptcy petition filed pursuant to the U.S. Bankruptcy Code will operate as a stay and bars either the commencement or continuation of a judicial or administrative proceeding against the debtor where the proceeding was commenced prior to the start of the bankruptcy proceeding or to recover a claim against the debtor that arose before the commencement of the bankruptcy proceeding." *Steele v. Metro. Edison Co.*, 2020 Pa. PUC LEXIS 444, at \*11 (Order entered Aug. 27, 2020) (citing 11 U.S.C. § 362(a)(1)).

23. The Commission has previously ruled that, pursuant to the United States Bankruptcy Code, the Commission lacks jurisdiction over arrearages for utility services that accrued prior to the filing of a bankruptcy petition. *Mickie Shreiber v. Respond Power, LLC*, 2015 Pa. PUC LEXIS 358 at \*17-18 (citing *Cooper v. PECO Energy Co.*, Docket No. F-09152102, (Order entered Jan. 12, 2006); *Stempo v. Metropolitan Edison Co.*, Docket No. C-2010-2200864, (Order entered July 19, 2012)). “The filing of a Petition with the United States Bankruptcy Court deprives the Commission of jurisdiction over this Complaint as all pre-petition debts become part of the bankruptcy estate to be appropriately discharged or distributed by the appointed Trustee in Bankruptcy.” *Larry E. Cooper v. PECO Energy Co.*, 2006 Pa. PUC LEXIS 29 at \*5-6 (Order entered Jan. 12, 2006). “The usual result of a Chapter 7 Bankruptcy Petition is that all unsecured pre-petition debts are discharged.” *Id.* at \*6.

24. In the Complaint, the Complainant requests a payment agreement for her electric service account balance with the Company. (*See* Complaint ¶ 4.)

25. The Chapter 7 Petition was filed in February 2025, more than 6 months after the Complainant filed her Complaint, and includes the Complainant’s pre-petition balance in arrears with Duquesne Light. *See Appendices A and B.*

26. The Complainant’s Chapter 7 Petition remains active as of the date of this Motion to Dismiss. *See Appendix C.*

27. A substantive order on this Complaint could affect the disposition of the income or assets of the Complainant, including the pre-petition arrears from her Duquesne Light account, which are under the control and jurisdiction of the United States Bankruptcy Court for the Western District of Pennsylvania.

28. Therefore, under well-established Commission precedent, the Commission lacks subject matter jurisdiction over the portion of the instant Complaint seeking a payment agreement because: (1) the Complainant has an active Chapter 7 bankruptcy proceeding; and (2) she is seeking a payment agreement on arrears with Duquesne Light that are included in her Chapter 7 Petition.

29. Thus, the Complaint should be dismissed because the Commission lacks subject matter jurisdiction over the Complainant's request for a payment agreement on her pre-Chapter 7 Petition arrears.

**B. THE COMPLAINT SHOULD BE DISMISSED DUE TO THE COMPLAINANT'S FAILURE TO APPEAR AND PROSECUTE HER COMPLAINT**

30. The Complaint should be dismissed with prejudice due to the Complainant's failure to appear for the scheduled hearing and prosecute her Complaint.

31. It is well-established that once a timely notice of a hearing and the opportunity to be heard have been provided, it is the responsibility of the parties to be present and participate in the hearing. *See Schneider v. Pa. PUC*, 479 A.2d 10 (Pa. Cmwlth. 1984); *Mumma v. PPL Elec. Utils. Corp.*, Docket No. C-00014869 (Order entered Jan. 24, 2002).

32. The Commission's regulations address circumstances when a party fails to appear in a proceeding. Section 5.245 of the Commission's regulations provide that, after being notified, a party who fails to appear at a scheduled hearing has waived the opportunity to participate. *See* 52 Pa. Code § 5.245(a)(1)-(3). In addition, Section 5.371 of the Commission's regulations provides for sanctions when a party fails to appear. *See* 52 Pa. Code § 5.371(a)(1).

33. The Complainant was advised through the hearing notices and prehearing orders issued in this proceeding that her failure to appear at the hearing could result in her Complaint being dismissed with prejudice.

34. By not appearing at this hearing, the Complainant has waived the opportunity to participate in the hearing under 52 Pa. Code § 5.245(a).

35. Importantly, the Commission has regularly dismissed customer complaints with prejudice due to the complainants' failure to prosecute. *See e.g., Vilma Mary DeMarco v. PECO Energy Company*, 2018 Pa. PUC LEXIS 447 at \*7 (Order entered Dec. 20, 2018); *Leon Zuckerman v. Columbia Gas of Pennsylvania*, 2013 Pa. PUC LEXIS 884 at \*3-4 (Order entered July 16, 2013); *ELCO Corporation d/b/a A&S Deli v. PECO Energy Co.*, 2013 Pa. PUC LEXIS 870 at \*9 (Order entered Aug. 29, 2013); *Dolores Mitchell v. Philadelphia Gas Works*, 2018 Pa. PUC LEXIS 85 at \*4 (Order entered Mar. 1, 2018); *Yomari Then v. Philadelphia Gas Works*, 2013 Pa. PUC LEXIS 1031 at \*5 (Order entered June 13, 2013); *Jody K. Butts v. Columbia Gas of Pennsylvania, Inc.*, 2017 Pa. PUC LEXIS 269 at \*3 (Order entered December 21, 2017); *Vanee Flowers v. PECO Energy Company*, 2025 PA. PUC LEXIS 21 at \*7 (Order entered Jan. 23, 2025); *Mary Jane Nestorick v. UGI Utilities, Inc.*, 2012 Pa. PUC LEXIS 266 at \*4 (Order entered February 16, 2012).

36. Thus, consistent with the Commission's regulations and precedent, Duquesne Light respectfully requests that the ALJ grant the instant Motion and dismiss the Complaint with prejudice due to the Complainant's failure to appear and prosecute the Complaint.

**III. CONCLUSION**

For the reasons set forth above, Duquesne Light Utilities Corporation respectfully requests that Administrative Law Judge Mary D. Long grant this Motion and dismiss the Formal Complaint filed by Tonya Lee Brown with prejudice.


