Re: Natural Gas Supplier License of KOBIONA LLC d/b/a Kb3 Advisors

Dear Mr. Vissat:

On September 12, 2025, KOBIONA LLC (KOBIONA) filed a request with the Pennsylvania Public Utility Commission (Commission) to change the name on its license to provide natural gas services, as a broker/marketer, to KOBIONA LLC d/b/a Kb3 Advisors.

Currently, KOBIONA is licensed as KOBIONA LLC as a broker/marketer to small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division<sup>1</sup>, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.

KOBIONA has provided the proper Pennsylvania Department of State documentation and has provided proof of service to the interested parties as required by the Commission.

Therefore, the Commission approves, by this Secretarial Letter, the change of KOBIONA LLC's name on its license for the provision of natural gas services as a broker/marketer.

**The Secretary's Bureau will issue a new license to KOBIONA LLC d/b/a Kb3 Advisors the right to begin to offer, render, furnish, or supply natural gas services as a broker/marketer to small commercial (under 6,000 MCF annually), large commercial (6,000 MCF or more annually), industrial, and governmental customers in the natural gas distribution company service territories of Columbia Gas of Pennsylvania, Inc., National Fuel Gas Distribution Corporation, PECO Energy Company, Peoples Natural Gas Company, LLC – Peoples Natural Gas Division, Peoples Natural Gas Company, LLC – Peoples Gas Division, Philadelphia Gas Works, UGI Utilities, Inc., and Valley Energy, within the Commonwealth of Pennsylvania.**


