Dear Secretary Homsher,

This letter is submitted on behalf of **Parsa Ariana LLC** in response to the Pennsylvania Public Utility Commission’s correspondence dated **October 8, 2025**, requesting additional information regarding our application for motor carrier authority. We appreciate the opportunity to clarify and strengthen our submission. Please find below our comprehensive responses:

1. Revised Proposed Service Area (Application Question #10)

Parsa Ariana LLC proposes to provide **paratransit service from points in the counties of Philadelphia and Bucks to points in Pennsylvania, and return.**

- a) Paratransit service between points in Lower Bucks County, including the municipalities of Bensalem, Bristol, Croydon, and Levittown.
 - b) Paratransit service between points (Northeast, North and South) in Philadelphia

2. Driver Qualification and Safety Compliance (Verified Statement Questions 5a–5e)

To ensure safe and compliant operations, Parsa Ariana LLC maintains a structured driver qualification and monitoring system aligned with Title 52 Pa. Code §§ 29.503–29.505:

- **§ 29.503 – Age Restrictions:**
All drivers must be **at least 21 years of age** at the time of hire. Age is verified through government-issued identification.
- **§ 29.504 – Driver History:**
A **PennDOT Motor Vehicle Record (MVR)** is obtained prior to hiring and reviewed **annually**.

Drivers must have no major violations (e.g., DUI, reckless driving) within the past three years. Records are retained for **five years**.

- **§ 29.505 – Criminal History:**

A **state and federal criminal background check** is conducted before hire and repeated **every three years**. Disqualifying offenses include violent crimes, theft, and endangerment. Records are securely stored in personnel files.

- **License Verification:**

All drivers must hold a valid **Pennsylvania driver’s license** appropriate for the vehicle class. Licenses are verified **prior to hire and annually**.

- **Drug and Alcohol Policy:**

Parsa Ariana LLC enforces a **zero-tolerance policy**.

- **Pre-employment drug testing** is mandatory.
- **Random testing** is conducted **semi-annually**.
- Any positive result or refusal to test results in immediate termination.

All compliance records are securely maintained and available for inspection upon request.

3. Statement of Financial Position

An updated and dated **Statement of Financial Position as of October 10, 2025** is attached. It reflects our current assets, liabilities, and equity, and meets the requirement of being completed within six months of application submission.

4. Clarification on Interstate and ADA Services

We respectfully clarify the following:

- **Interstate Service:**

Our application is strictly for **intrastate paratransit service** within Pennsylvania. We understand that interstate operations fall outside the scope of PUC authority and are not included in this application.

- **Wheelchair and Stretcher Services:**

Our current fleet consists of **non-ADA-equipped vehicles** suitable for ambulatory passengers only.

We intend to expand into **wheelchair and stretcher transport** once ADA-compliant vehicles—equipped with ramps/lifts and securement systems—are acquired and inspected per **67 Pa. Code § 175 and 49 CFR Part 38**.

We will notify the Commission and submit updated documentation when such vehicles are added to our fleet.

5. Verification Statement
