PETITION FOR EXTENSION OF TIME

NOW COMES Peoples Natural Gas Company LLC (“Peoples”) and, pursuant to 52 Pa. Code § 5.41, petitions for an extension of time to complete the work that has been approved in the captioned matter. In support of its Petition, Peoples states as follows:

1. The name and address of petitioner: Peoples Natural Gas Company LLC, 375 North Shore Drive, Pittsburgh, Pennsylvania 15212.

2. The name and address of applicant’s attorney: Meagan Moore, 375 North Shore Drive, Pittsburgh, Pennsylvania 15212.

3. By Secretarial Letter dated July 31, 2024, the Pennsylvania Public Utility Commission (“Commission”) granted Peoples’ application in this matter directed that “The alteration of the crossing be completed on or before August 31, 2025[.]” Due to construction scheduling issues, Peoples was unable to complete the approved alteration by August 31, 2025, and now projects that it will be able to complete the work on or before December 31, 2026. Construction of the work was delayed due to crew availability during the 2025 construction season.


4. Accordingly, Peoples respectfully requests an extension of time to complete the alteration of the crossing from the August 31, 2025 due date contained in the July 31, 2024 Secretarial Letter to an extended date of December 31, 2026, and that Paragraph 8 of the Secretarial Letter dated July 31, 2024 be modified as follows:

8. The alteration of the crossing be completed on or before ~~August 31, 2025~~
December 31, 2026 and that on or before said date Peoples Natural Gas Company
LLC report in writing the date of actual completion of the work to this
Commission and certify to the parties of record and this Commission that the
work has been completed satisfactorily in accordance with the approved plan and
this Secretarial Letter.

Wherefore, Peoples Natural Gas Company LLC requests that the Commission’s Secretarial Letter in this matter dated July 31, 2024 be modified consistent with this Petition.


