**ORDER
TRANSFERRING CASE TO TUS**

On June 30, 2025, UGI Utilities, Inc. – Gas Division (UGI Gas) filed an Application with the Pennsylvania Public Utility Commission (“Commission”) requesting approval for the right to provide natural gas service to a portion of Frailey Township, Schuylkill Township, Pennsylvania. Notice of the Application was published in the *Pennsylvania Bulletin* on July 12, 2025, which set a July 28, 2025, filing deadline for Formal Protests and Petitions to Intervene. On July 28, 2025, the Office of Consumer Advocate (“OCA”) filed a Protest, Public Statement, and Notice of Entry of Appearance. There are no other parties to the case.

On August 22, 2025, a Telephonic Prehearing Conference Notice was issued, scheduling a telephonic prehearing conference for 10:00 AM on September 9, 2025, before Administrative Law Judge Steven K. Haas (“ALJ”). The Prehearing Conference was held as scheduled and a litigation schedule was discussed and adopted.

On October 6, 2025, the OCA filed a Notice of Withdrawal of its Protest. By e-mail dated October 6, 2025, I was informed by counsel to the OCA that, based on discovery responses and informal discussions with the company, all of the OCA’s concerns with UGI Gas’ application had been addressed.

As the lone Protestant has withdrawn its Protest, this matter is no longer contested and there are no issues requiring an evidentiary hearing. Therefore, it is appropriate that this matter be transferred to the Commission's Bureau of Technical Utility Services for disposition.

THEREFORE,

IT IS ORDERED:

1. That the Application of UGI Utilities, Inc. – Gas Division, at Docket No. A-2025-3056029 is hereby transferred to the Commission's Bureau of Technical Utility Services for disposition.
