Dear Secretary Homsher:

On October 3, 2025, UGI Utilities, Inc. – Electric Division (“UGI Electric” or “Company”) was served with the Complaints filed by Radial Power LLC (“Radial Power” or “Complainant”) at the above referenced dockets. UGI Electric’s Answers to the Complaints are due on October 23, 2025. UGI Electric and Radial Power have been in contact since the Complaints were filed and are actively pursuing resolution of the Complaints without the need for further litigation. As part of those discussions, both parties have agreed to pursue mediation of these matters. Therefore, UGI Electric respectfully requests that these matters be transferred to the Commission’s mediation unit to allow the parties time to engage in settlement negotiations.

In addition, UGI Electric respectfully requests an extension of the due date for filing UGI Electric’s Answers and/or any other responsive pleadings until 20 days after the mediation process has concluded in these matters. The answering deadline set forth in Section 5.61 of the Public Utility Commission’s regulations is within 20 days after the date of service, “[u]nless a different time is prescribed by statute, the Commission, or the presiding officer . . . .” 52 Pa. Code § 5.61(a).

UGI Electric has discussed both of these requests with the Complainant and is authorized to represent that the Complainant agrees with these requests.


