**INTERIM ORDER
ON MOTION TO STRIKE**

On June 2, 2025, Wellsboro, along with Valley Energy, Inc. and Citizens' Electric Company of Lewisburg, PA moved to consolidate the proceedings with Valley Energy's and Citizens' 2025 Base Rate Filings. Kelly Road Solar, LLC, Lancaster Avenue Solar, LLC, and Twilight Renewables, LLC (collectively, Solar Projects), filed a petition to intervene in the case of Citizens' Electric, Docket R-2025-3054394, on May 21, 2025.

A prehearing conference was convened on June 3, 2025. Solar Projects petition to intervene in the Citizens' Electric base rate proceeding was granted. I also granted the Company's request to consolidate the base rates of Citizens, Wellsboro and Valley Energy for the purposes of discovery and litigation. However, I stated that each rate request must be supported by its own record. Evidentiary hearings were convened on September 4, 2025. Following the hearing I issued separate orders in each case regarding the filing of settlement petitions, and in the case of Citizens' briefs regarding Solar Projects objection to the settlement and position on the contested issue.

Solar Projects filed a Main Brief on September 26, 2025, in support of its position in the Citizens Base Rate. However, the caption on Solar Projects' brief included the caption and docket number for the Wellsboro Base Rate, a case in which it is not a party.

On October 10, 2025, Wellsboro filed a Motion to Strike Solar Projects' Main Brief from the docket in the Wellsboro Base Rate. Subsequently, Solar Projects admitted that the Main Brief filed at the Wellsboro Base Rate Docket was an error. Solar Projects filed a revised brief at the Citizens docket removing the Wellsboro Base Rate caption from the brief.

I notified the Parties that in view of Solar Projects admission that the filing of the Main Brief on the Wellsboro docket was an error, I viewed Wellsboro's motion to strike as moot. By email on October 15, 2025, Counsel for Solar Projects notified me that he contacted Commission's Secretary's Bureau to correct the error.

However, the Solar Projects brief has not yet been removed from the Wellsboro docket. In order to ensure that the record is clear, the purpose of this order is to expedite the removal of Solar Projects Main Brief from the Wellsboro Base Rate Docket.

THEREFORE,

IT IS ORDERED:

1. Wellsboro Electric Company's Motion to Strike the September 26, 2025, Main Brief of Solar Projects is granted.

2. That the Secretary's Bureau shall remove the document from Docket R-2025-3054392 promptly.
