The Public Utility Commission (PUC) will hold an in-person public input hearing concerning Energy Center Harrisburg LLC's General Base Rate Filing, including its proposed changes and increases to tariffed rates for steam services pursuant to 66 Pa.C.S. § 1308.

**Participating in a Public Input Hearing:** To testify at a public input hearing, you are encouraged to pre-register by **4 p.m. on Wednesday, November 5, 2025**. Pre-registration is not required to testify at the in-person public input hearing.

**PRE-REGISTRATION INFORMATION:** Whether pre-registering by email or telephone, in both cases, provide the following information:

- (1) your first and last name,
- (2) the phone number you will be using to call into the public input hearing,
- (3) a phone number where you can be reached prior to the hearing if we need to contact you, and
- (4) your email address, if you have one.

Additionally, members of the public who do not wish to testify but want to listen to the public input hearing may attend the hearing in person.

**NEED ASSISTANCE WITH PRE-REGISTRATION?** If you need assistance pre-registering to testify, you may have someone register for you, but they will need to provide the PUC Judges with all the information listed above. Additionally, if more than one person in your household would like to testify, one person may pre-register for other individuals in the same household by providing the PUC Judge's Legal Assistant with the above-listed information for each individual.

**REQUESTS FOR INTERPRETERS:** If you require an interpreter, please pre-register as soon as possible. If you register too close to the hearing date, we may not have enough time to arrange for an interpreter. If you request an interpreter, the PUC will make reasonable efforts to have one present.
