PREHEARING CONFERENCE ORDER

(d) Parties and counsel will be expected to attend the conference fully prepared for a useful discussion of all problems involved in the proceeding, both procedural and substantive, and fully authorized to make commitments with respect thereto.

3. That the Parties should be prepared to discuss at the further prehearing conference:

- a) A procedural schedule, including dates for the submission of written testimony and exhibits.
- b) An evidentiary hearing date or dates, and whether the hearing should be held telephonically or in-person in Philadelphia, Pennsylvania.
- c) Any other relevant procedural matter.

4. That the Parties are not required to file prehearing memorandum in advance of the conference.
