

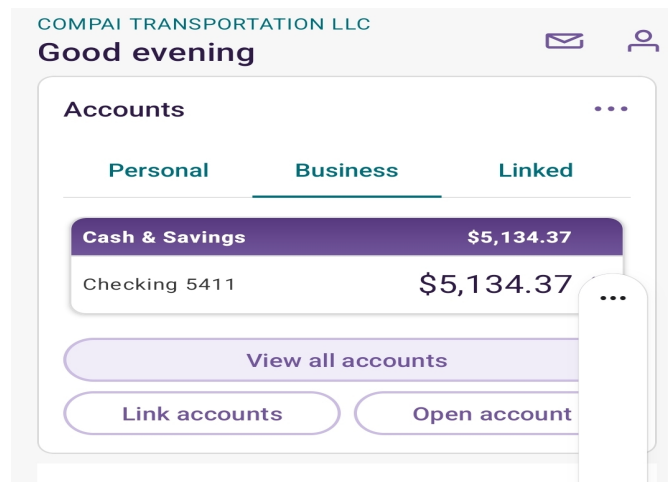



Company Overview

Compai Transportation LLC is a Pennsylvania-based paratransit service operated by owner and driver Pablo Gonzalez. The company provides safe, reliable, and professional 'door-to-door' transportation for private clients and students within Hazleton and surrounding areas of Luzerne County.

1. Driver Qualifications and Compliance

- The company employs only one driver (Pablo Gonzalez), who holds a valid Pennsylvania driver's license with the appropriate class for paratransit operation. - A copy of the driver's license and driving record is maintained in the company's compliance file. - Driver record and background checks are reviewed annually to ensure continued eligibility to operate. - The driver completes an annual drug and alcohol test to maintain compliance with PUC safety standards.

2. Vehicle Maintenance and Inspection Plan

- The company operates one vehicle (2013 Ford E-350) owned by Compai Transportation LLC. - A pre-trip inspection is performed before each service day, checking lights, brakes, seat belts, tires, and fluid levels. - Routine maintenance, including oil changes, is performed every 3,000–5,000 miles, or sooner if required. - A maintenance record log is kept to document service dates, mileage, and completed work. - A sample pre-trip inspection checklist is maintained and available upon request.


3. Insurance and Safety Compliance

- The vehicle is insured under Berkshire Hathaway Homestate Insurance Company, meeting all PUC minimum financial responsibility requirements. - Proof of active insurance coverage is carried in the vehicle at all times. - The company ensures all safety equipment is operational and the vehicle passes Pennsylvania state inspections on schedule.

4. Recordkeeping and Documentation

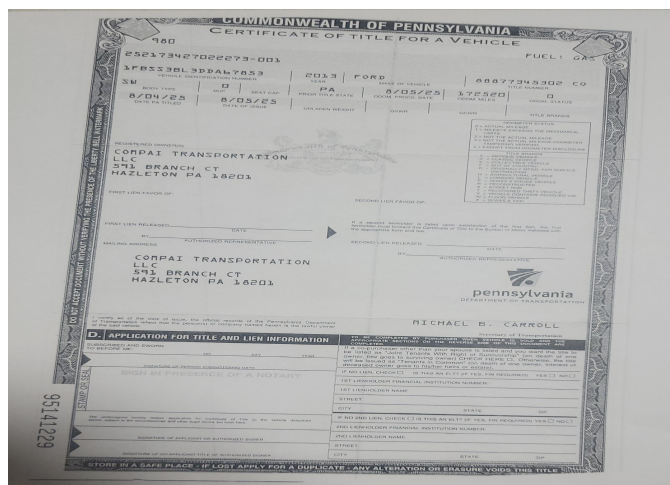
