**ORDER**  
**DENYING MOTION FOR ADMISSION PRO HAC VICE**

On August 21, 2025, Walter Fey (Complainant or Mr. Fey) filed a Formal Complaint against Rushmore Energy, LLC (Respondent or Rushmore) with the Pennsylvania Public Utility Commission (Commission) alleging that his energy supplier was changed without his permission.

On October 13, 2025, Counsel for Respondent, Christopher C. Wilcoxson, Esquire, filed a Motion for Admission Pro Hac Vice of Natara Feller (Motion), requesting that Natara Feller, Esquire, be permitted to appear on behalf of Respondent in the above-captioned case, pursuant to 52 Pa. Code §§ 1.22(b) and 5.103 and Pa. B.A.R. 301 and 1012.1.

The Motion failed to include a Notice to Plead in violation of 52 Pa. Code § 5.103(b), which states:

*Presentation of motions.* A motion may be made in writing at any time, and a motion made during a hearing may be stated orally upon the record, or the presiding officer may require that an oral motion be reduced to writing and filed separately. *Written motions must contain a notice which states that a responsive pleading shall be filed within 20 days of the date of service of the motion.*

52 Pa. Code § 5.103(b) (emphasis added). Thus, the Motion is defective and shall be denied.

It should be noted that regulations requiring notice are especially important in matters involving parties appearing *pro se*.
