





UNOPPOSED MOTION FOR CONTINUANCE OF PECO ENERGY COMPANY

PECO Energy Company (Respondent or Company), by and through its attorneys, Reger Rizzo & Darnall LLP, and pursuant to 52 Pa. Code § 1.15, respectfully requests that the Honorable F. Joseph Brady (Judge Brady) of the Pennsylvania Public Utility Commission (Commission) grant its Motion for Continuance (Motion) and issue an order continuing the scheduled Call-in Telephonic Hearing for November 6, 2025 (Hearing) as the Company’s fact witness, Michael Begley, is unavailable for the Hearing.

In support thereof, the Company avers as follows:

1. On July 30, 2025, Larry Watts (Complainant) filed a Formal Complaint seeking a Commission PAR to establish service in his name for residential electric service provided to 1818 Orthodox Street, Philadelphia, Pennsylvania (Service Address) under finalized Account No. 2789779000 (Closed Account).

2. On August 25, 2025, the Company filed an Answer denying the material allegations therein.

3. By Notice, dated August 28, 2025, an Initial Call-In Telephonic Hearing was scheduled for Thursday, November 6, 2025, before Judge Brady.

4. 52 Pa. Code § 1.15 (b) states:

(b) Except as otherwise provided by statute, requests for continuance of hearings or for extension of time in which to perform an act required or allowed to be done at or within a specified time by this title or by order of the Commission or the presiding officer, shall be by motion in writing, timely filed with the Commission, stating the facts on which the application rests, except that during the course of a proceeding, the requests may be made by oral motion in the hearing before the Commission or the presiding officer. Only for good cause shown will requests for continuance be considered. The requests for a continuance should be filed at least 5 days prior to the hearing date.


5. The unavailability of the Company's fact witness, Michael Begley, constitutes good cause consistent with Commission regulation.

6. On October 29, 2025, the office of undersigning Counsel contacted the Complainant *via* telephone to notify him of the Company's need for a continuance of the scheduled hearing, and the Complainant advised that he had no objection the Company's request.

7. The Company respectfully requests the Call-in Telephonic Hearing be rescheduled for a date after November 6, 2025.

WHEREFORE, for good cause shown, PECO Energy Company requests that the Honorable F. Joseph Brady grant its Unopposed Motion for Continuance of the scheduled November 6, 2025, Initial Call-In Telephonic Hearing.
