RULES & REGULATIONS

- 1) Advance reservations are required and must be made 12 hours prior to service being rendered.
- 2) Hourly rates commence at the time the vehicle leaves the office and shall conclude when vehicle returns to the office. "Garage to Garage."
- 3) Additional expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip. Expenses for driver's lodging and meals while on trips out of town which are in excess of ten (10) hours will be added to the basic charge.
- 4) Promotional Fares / Discounts: Upon presentation of an advertised coupon or other special promotional offer, the carrier will offer rates at a specified discount from the published tariff rates on the dates authorized by the coupon or offer. Advertised coupons or other special offers will be filed with the PA Public Utility Commission prior to publication or broadcast in one or more of the following: local newspapers, radio and television advertising, flyers, postcards, or other printed media, and the Internet.
- 5) No deposits will be made on reservations

SCHEDULE OF RATES

Hourly Rates: Minimum charged will be for 2 hours, or any fraction thereof.

Additional time will be charged in thirty (30) minute / half hour increments, or any fraction thereof, at the following rates:

Standard Hours: 6:00 AM to 10:00 PM

Luxury SUV: \$90.00 / Hour

Additional 30 Minutes, or any fraction thereof: \$45.00 / Half Hour

All other hours or days not listed above are subject to the same rate.

Flat rates: These are given at the request of the customer and are based on the estimated hourly rate for service requested. The price is negotiated and agreed upon before service is conducted. Hourly rate will be charged for any service requiring any extra charges such as parking, tolls, etc.

Customers are charged the hourly rate upon reaching the final destination. If any tolls or parking occur during service, the customer is charged once the vehicle returns to the office and the total fees for parking/tolls are compiled and sent to the customer as a final invoice.
