LIST OF CHANGES MADE BY THIS TARIFF

Advanced Reservations – changed from a minimum of a 1-hours' notice on all reservations, to a minimum of 15-minutes.

Waiting Time – Increased waiting time from \$1.00 every 5-minutes or fraction thereof, to \$3.00 every 5-minutes or fraction thereof

Senior Citizens Rates – Deleted.

Escort Service – Deleted

Hourly Rates – Defined that charges were calculated from the beginning and end from of the customer's pick-up to the customer's drop-off. This changed from carrier's garage back to carrier's garage.

Additional Expenses – added rules allowing for define additional charges.

Mileage Rates – added mileage rates as defined herein.

Flat Rates – added flat rate options as defined herein.

Operating Authority

To Transport, as common carrier, persons in paratransit service, between points in the city and county of Philadelphia.

RULES AND REGULATIONS

(C) Advance Reservations- Reservations must be made at least 15-minutes prior to service being rendered.

(C) (A) Waiting Time –

First (5) minutes, no charge.

After (5) minutes – \$3.00 for each 5-minutes or fraction thereof

Contract Clause – Contract services will be for a term of not less than 30 days for pre-qualified persons under a federal, state, county or municipal government agency contract. Rates for the services will be specified in the respective contracts, copies of which, including any amendments thereto, are to be filed with the Commission as executed to become effective on one day's notice.

(C) Hourly Rates – Rates begin and end from the customer's pick-up to the customer's drop-off.

(C) Mileage - Rates shall be calculated by the odometer of the vehicle used and will be calculated from beginning and end from the customer's pick-up to customer's drop-off.

(C) Additional Expenses - Addition Expenses necessitated by or incurred at the request of the passengers, including but not limited to, highway tolls, bridge tolls, entrance fees and parking, shall be added to the charge of the trip.

(C) – Indicates change or addition

(A) – Indicates increase in rates.

SCHEDULE OF RATES

(C)(A) Hourly Rates

Rates begin and end from the customer's pick-up to the customer's drop-off.

Hourly rates will be based on charged at a rate of \$36.00 per hour.

(C) Mileage Rates

Flat Rates – For all loaded miles trips from point of pickup to point of drop off:

\$10.00 per one way trip

\$20.00 per round trip

Mileage Rates – Apply in addition to the flat rates stated above for all loaded miles from the point of pickup to the point of drop-off: \$3.00 per mile, or fraction thereof, after the first 2 miles.

Waiting Time – First (5) minutes, no charge.

After (5) minutes – \$3.00 for each 5-minutes or fraction

(C)(A) Flat Rates:

\$25.00 One Way

\$45.50 Round Trip

Mileage Rates – for each mile beyond the initial 7 miles on all loaded miles from the point of pick-up to the point of drop-off: \$3.00 per mile or fraction thereof
