Dear BRADLEY G COLE:

This letter is notification that your utility has outstanding assessment balances with the Commission. The past due balance is \$59.00, which includes \$44.00 for 2025-26 and \$15.00 for prior years.

You are required to pay the past due balance within twenty (20) days after the date of this letter. If you fail to pay this balance, the Commission will institute appropriate legal action against you.

Pursuant to the Public Utility Code 66 Pa. C.S. §510 (c), a certificated public utility is required to pay its assessment within 30 days after receipt of the original invoice, your failure to pay this assessment is a violation of the Public Utility Code and subjects you to legal action by this Commission including, but not limited to, the imposition of a civil penalty of \$1,000 per day for a continuing violation. The Commission will suspend or revoke certificates of public convenience and request suspension or revocation of automobile registration with the Department of Transportation.
