Affidavit of Truth

Statement of Facts

I, Patrece Glenn, am of lawful age and competent to testify to the matters herein. I make this Affidavit of Truth voluntarily, of my own free will, and under penalty of perjury.

Aqua Pennsylvania, Inc. has reported or attempted to collect charges against my account relating to water service at 1206 Calcon Drive, Sharon Hill, PA 19079.

I have previously disputed these charges through proper channels and provided lawful remittance instruments for settlement and discharge of the alleged account.

Despite this, Aqua Pennsylvania closed my account, issued shutoff notices (though no shutoff occurred), and sent communications inconsistent with the Uniform Commercial Code, SEC filings, and federal accounting standards.

Demand for Truth

The Respondent, Christopher H. Franklin, CEO & Chairman of Aqua Pennsylvania, Inc., is hereby required to issue a Notarized Affidavit of Truth swearing to the following:

That the service application I executed with Aqua Pennsylvania was not securitized, pledged, or monetized through any securities, bonds, or other financial instruments filed with the U.S. Securities and Exchange Commission.

That no dividends, earnings credits, or interest accrued from the securitization of my account, and that no such credits exist that could offset or extinguish the charges alleged against me.

Provide a complete itemized statement of account activity, charges, credits, and payments, including internal ledgers.

Identify how funds or remittances have been applied.

Authority to Collect

If you are represented by counsel or a third-party collection agent, provide proof of their authority and standing to collect or litigate on this account.

Affidavit Requirement

Provide a notarized affidavit from Christopher H. Franklin, CEO & Chairman, swearing that:

The account was not securitized or monetized through securities or bonds;

No dividends or credits exist that could offset charges;

The billing statements/remittance coupons are not negotiable instruments;

The accounting records provided are true, correct, and complete.

Notice to Respondent

You are hereby given 15 calendar days from receipt of this letter to provide the requested validation. Failure to do so shall constitute an admission that:


No valid obligation exists;

Aqua Pennsylvania has no standing to collect;

Any continued collection or reporting activity will constitute fraud, defamation, and violation of federal and state law.

I am formally disputing the alleged debt and demanding full validation pursuant to applicable federal and state law, including but not limited to the Fair Debt Collection Practices Act (FDCPA, **15 U.S.C. § 1692g**), the Fair Credit Reporting Act (**15 U.S.C. § 1681s-2**), and Pennsylvania consumer protection laws.

As the alleged creditor and/or collector, you are required to provide the following:

Chain of Title / Standing

Provide documentation proving Aqua Pennsylvania, Inc. is the rightful party with standing to claim this debt.

Identify any assignment, transfer, or sale of the account, and provide copies of such agreements.

That Aqua Pennsylvania has not sold, assigned, or transferred my account to any third party for collection or securitization purposes.

That the accounting records and ledgers provided by Aqua Pennsylvania are complete, accurate, and reflect the true disposition of all funds, credits, and instruments connected to my account.

Notice to Respondent

Failure to respond with a notarized affidavit rebutting each point within 15 calendar days shall constitute agreement, admission, and confession that all statements herein are true, correct, and binding upon Aqua Pennsylvania, Inc.

A failure to rebut shall further constitute an admission of unlawful securitization, unjust enrichment, and constructive fraud.


Re: Questions Submitted on the Record regarding applicability of the Pennsylvania Right-to-Know Law in the above-captioned matter.

Judge, Just to ensure I'm speaking with the right persona; can you confirm if you're operating under a corporate identity or if this is more of a personal endeavor? Are you under oath?

1. Just to clear up any potential identity mix-ups, can we confirm if the entity in question stands alone as a separate legal entity, distinct from the individual present here in court?
2. Is the Plaintiff legally recognized as a decedent?
3. Is the court legally blind, or classified as being unaware or unseeing of pertinent details or evidence in this case?
4. Does being legally blind qualify the court for certain benefits, protections, and accommodations under the law, as used by government agencies and legal systems to determine eligibility for disability benefits, tax exemptions, and other support services?
5. Are the courts attempting to use identity confusion to force a third party to act as surety in this case? If not, will the judge and the courts ensure the surety is properly identified?

6. Can the court provide evidence that this case is directly related to legitimate business expenses and not personal or off-ledger activities?
7. What measures are in place to ensure that the presiding judge does not have any conflicts of interest or personal involvement in the case?
8. Judge , have there been any allegations that you are involved in gambling,wagering,phishing or other illicit activities while serving on the bench?
9. Is there a possibility of requesting an Independent review or oversight of the case to ensure fairness and transparency in the judicial process?
10. Has there been an Independent audit of the Plaintiffs business accounts to verify the legitimacy of all charges, transactions and expenses?
11. Is there an appearance bond in place? If so, will the clerk compensate me for participating in what I believe to be a frivolous case?
12. Has Congress been informed about the courts' practice of creating financial obligations through judgements?

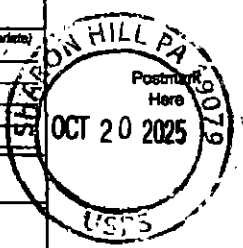

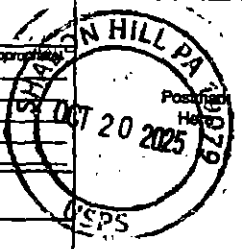
