Attached to this Petition is the company's revised and fully compliant Driver Hiring and Employment Policy, which addresses all regulatory concerns under 52 Pa. Code § 41.14(4).

As the sole owner and current operator, I, Myhiar Aboussaad, have implemented the enclosed policy to ensure all future hiring, background checks, and training comply with Commission standards. Mirra Car Service LLC maintains active limousine insurance coverage and is prepared to operate safely, efficiently, and reliably under the Commission's authority.

For these reasons, Mirra Car Service LLC respectfully requests that the Pennsylvania Public Utility Commission reconsider its prior decision and grant the Certificate of Public Convenience.

Driver Hiring and Employment Policy

Mirra Car Service LLC is committed to maintaining the highest standards of safety, professionalism, and regulatory compliance in the hiring and employment of limousine drivers. Currently, the company has one active operator — the owner, Myhiar Aboussaad — who performs all driving duties. As the company grows, the following policies will apply to all future driver hires:

1. Application and Screening

All applicants will be required to submit a completed employment application, provide valid driver's license and driving history, and authorize background and motor vehicle record checks. Only applicants with a clean driving record and no disqualifying criminal offenses will be considered for employment.

2. Background and Safety Checks

Prior to hiring, Mirra Car Service LLC will conduct Pennsylvania State Police criminal background checks and driving record checks through PennDOT or an equivalent authorized provider. All records will be reviewed to ensure compliance with 52 Pa. Code § 29.331 and related safety standards.

3. Drug and Alcohol Testing

Pre-employment and random drug and alcohol testing will be conducted in compliance with U.S. Department of Transportation and Pennsylvania PUC safety requirements. Any driver who fails or refuses a test will be disqualified from service.

4. Training

All new drivers will undergo training in defensive driving, vehicle maintenance awareness, passenger safety, and customer service. Training records will be maintained in the company's files for Commission review.

5. Insurance and Compliance

Mirra Car Service LLC has secured limousine insurance coverage and ensures all drivers are added to the insurance policy before operating any company vehicle. The company will remain in full compliance with Pennsylvania PUC and DOT safety and insurance regulations.

6. Recordkeeping

All employment, screening, and training records will be kept in the company's central office and made available to the PUC upon request. Mirra Car Service LLC is dedicated to ensuring the safety and reliability of its limousine operations at all times.
